



Baseball PEI Discipline Guidelines Policy-REVISED 2025

1.1 Introduction

These discipline guidelines apply to all Baseball PEI exhibition, regular season, tournament, Eliminations, and Provincial Championship games. Baseball PEI reserves the right to adjust discipline based on individual circumstances. Key elements include:

- **Authority to Discipline:** Baseball PEI's Board of Directors and/or the designated Director or Executive Director, may discipline or suspend players, coaches, or team personnel, *regardless of ejection status*.
- **Umpire Abuse:** In serious cases of umpire abuse, a meeting may be convened involving the suspended individual, their minor baseball association president, a PEI Baseball Umpires Association representative, and other relevant parties to review the incident and determine further action. The Director may adjust the suspension based on the meeting outcomes.
- **Repeat Offences:** Additional one-game suspensions will apply for each subsequent ejection during a season, on top of standard discipline.
- **Prolonged Arguments After Ejection:**
 - First offence: One (1) additional game suspension.
 - Second offence: Two (2) additional game suspensions.
 - Third offence: Indefinite suspension pending a hearing with Baseball PEI.

- **Ejection Protocol:** Ejected individuals must leave the dugout (beyond the outfield fence, not allow behind the backstop, sideline bleachers or down either baseline) and may not contact or communicate with players, teams, or umpires during or after the game *verbally or by phone/text*. They must remove any part of their uniform that identifies them with the team. They can not communicate with the umpire after the game and the umpire shall not initiate contact or communication either. In both instances the individual will be subject to discipline for that action. If an ejected person chooses not to leave the park (and remains beyond the center field fence), they should be *inconspicuous and silent* for the remainder of the game. They can not return to the field for handshakes or any post games meetings at the field
- **Suspension Enforcement:** Ejected individuals are suspended automatically for the minimum amount based on the BPEI Suspension Guidelines, if the suspension is more than the minimum they will be notified by Baseball PEI, if they are unsure of the minimum amount they can contact their director or the BPEI ED for clarification. If ejected during a doubleheader, they are ineligible for subsequent games unless they are sure they are not suspended. If there is any doubt sit out the game.
 - **If ejected member continues to be a problem “post ejection” it will be considered a “next” offence and will be subject to discipline as such.**



- **Suspension Applicability:**
 - Suspensions earned in Baseball PEI competitions apply to Baseball Canada, Baseball Atlantic, and Provincial team games.
 - Suspended players or coaches cannot participate in games outside Baseball PEI jurisdiction during their suspension.
 - All games served under suspension MUST have been previously scheduled. A new game may NOT be scheduled for the purposes of serving a suspension.
- **External Suspensions:** Suspensions issued by Baseball Canada or other provincial baseball organizations will be enforced by Baseball PEI.

- **Criminal Offences:** Criminal activities during Baseball PEI events must be reported to local authorities and Baseball PEI by any witness.

- Suspended Persons may attend games while they are under suspension but must watch the game from the outfield (they can not be behind the backstop or down either foul line) and may not communicate with anyone on either team or the umpires in any way.

2025 Additions

- 13UAAA, 15UAA, 15UAAA and 18UAA pitching violations will now also carry a team fine in addition to ejection and suspension. This team fine must be paid within 48 hours of notification to remain in good standing with BPEI and eligible to participate in their next league game.
- BPEI representatives such as board of directors, umpire mentors, and tournament supervisors have the authority to eject persons from any game when warranted.
- Any BPEI player, umpire, coach, manager or other volunteer can be suspended for violation of code of conduct or non-confrontation policy at any BPEI event regardless of whether they are a participant or spectator.

6.2 Honoring Suspensions

- All Baseball PEI Member Organizations and Affiliates shall honor the suspensions issued by one another.
- All Baseball PEI Member Organizations and Affiliates shall share suspension information with the other member groups.
- Failure to uphold the suspension policy will place any member group as “not in good standing” with Baseball PEI.
- Examples of Member Groups honoring suspensions
 - A coach who has been suspended as a coach in their league, who also umpires, shall not umpire until the suspension has been fully served.
 - A player who has been suspended as a player in their league, who also umpires, shall not



- umpire until the suspension has been fully served.
- An umpire who has been suspended from umpiring, who also plays as a player or coaches, shall not play or coach until the suspension has been fully served.
- A player who has been suspended in a league they play in, who also plays in another league, shall not play in any league until the suspension has been fully served.
- It is incumbent upon each member organization and affiliate to communicate this policy to its members to insure they are fully aware and do not unwittingly violate this policy.

- Any conduct during off Island play that results in a suspension issued by Baseball PEI shall also be honored by all other Member Organizations and Affiliates
- If you are suspended in a league without the ability to serve your suspension in that league, it is required that you serve that suspension in the next league in which you participate.
