 - e. Poll concerning going forward with audit of RAB financials. 38 out of 43 responded to waive the audit.
5. Registrar's Report
 - a. Record number of registrations. We would have to go back to 2017 to find similar numbers.

6. BLAST Tournament Report

- a. 151 volunteers donated 459 hours of their time
- b. 50/50 was very successful and has continued to help our association grow.
- c. 3,628 50/50 tickets sold (total pot \$21,370)
- d. The tournament raised \$26,349!
- e. Often get feedback from outside teams saying its the best tournament that they take part in. Other associations have tried to match our fundraising and have not been able to. Congrats RAB!!!

- a. Started Inside Edge which allows the voices of the players to be heard, and share feedback.
- b. Main feedback was the need for an end of the year banquet. Looking to start this in the coming season to acknowledge successes of players and staff.
- c. Looking to add mental health supports for players
- d. Shield was offered to Provincial teams. Regional teams were looking to get involved in this. We would like to expand to this in the future.
- e. We would also like to invigorate the goalie development program.
