R4U

- Has there been discussion if a U8 type setting would work to split players into 2 groups?
 - Ringette Manitoba will be meeting and all associations will come together to discuss more development.

Fees

- What is all included in the fees? Why are jerseys being purchased at U10 level?
 - We went to this new format a couple of years ago, # sticks with the player through their playing career.
 - Was lots of work to keep track of jerseys and replacing jerseys etc.

Icetime cost for U10

- Why is there a jump in cost for icetime for U10?
 - Registration cost covers games and officials but at U10 you will then have to pay on top of registration for the practice ice and tournaments that the team enters.
 - # of practices are discussed with the parents at the start of the season. Collected throughout the season. Can also do fundraising to help bring the cost down.
