- Projected Excess Revenues over Expenditures for year ended April 30, 2015 of \$7,612
- Budgeted Excess Expenditures over Revenues for year ended April 30, 2015 was \$14,000 – decrease in actual Expenditures over Revenues compared to budget was primarily a result of decreased spending on Development programs combined with the elimination of the annual yearbook
- Net Asset position of \$167,000 as at April 30, 2015 result of last 7 years Excess Revenues over Expenditures of \$48,000 in 2009, \$24,000 in 2010, \$64,000 in 2011, \$20,000 in 2012, \$4,000 in 2013, \$0 in 2014 and \$7,000 in 2015
- Current cash position of \$263,000 due to 2015 / 2016 registrations starting in April 2015
- Registration Fees for the 2015 / 2016 season have increased slightly due to continuing increasing costs of ice, material and overhead costs

DIRECTOR SR HOUSE LEAGUE REPORT

The 2014-2015 season had a total of 8 teams with 11 players and a goalie on each team. We were down in numbers drastically this season from the 2013-2014 season due to injuries, surgeries and pregnancies, but we are hopeful many of the missing players will return next season.

This year each team played a total of 24 games, 3 of which were playoff games. This season's 1st place team and playoff champion was the Pink team.

Some of the changes made this season, voted at the team rep meeting in February:

- Decreasing the total number of games in the 2015-2016 season from 24 to 19, each team
 will play the other twice and still maintain 3 playoff games. This will also be done to avoid
 holiday weekends such as Thanksgiving, New Years and March Break where most
 players are missing. This will help decrease the number of pick-ups needed throughout the
 season.
- Collecting this season's jerseys and reusing for the next 3 seasons, to decrease costs. Next season team reps will put down a \$50 deposit when they pick up their team jerseys and will receive their deposit upon return of the jerseys at the end of the season.
- Continuing with the 2-man ref system. We had a trial period of the 3-man ref system, but found the increase in cost and congestion on the ice were unnecessary. Team reps voted to stick with 2 refs for the 2015-2016 season.
- Eliminating the evaluation skate. This skate was used to evaluate new players to the league and was mandatory, but in the two seasons I have been rep, less than 50% of the new players attend. Again, this is an unnecessary cost.

All of the changes made were done so to decrease costs and attract more players back to the league. The increase in cost in the 2014-2015 season detoured many players away, as well as a longer season. We hope to bring back some of the players and attract new players with the changes made.

Lastly, this is my final season as Director of Senior House. I want to thank everyone for a successful two seasons, which have been enlightening and fun. I have had a great time as your rep and look forward to my future endeavors.

I would like to officially welcome our new Director of Senior House, Lindsay Anderson. She has been with the senior league for the last two seasons, a temporary administrative assistant at the BWHA office and a house league coach for the last few seasons. She brings a lot of experience and enthusiasm to our league, and I am happy to pass the torch to such a great individual.

DIRECTOR of ICE SCHEDULER REPORT

For the 2014 – 2015, season the Barrie Sharks used approximately 2058 hours of ice. Of which:

- 170 hours at Innisfil, Lefroy & Stroud
- 100 hours at NTR
- 64 hours at Nottawasaga
- 16 hours were at Thornton
- Total of 250 hours (12%) of our ice allocation was non City of Barrie ice (down from last year of 21%).
- An additional 283 hours were used for Sharkfest

For the, 2012-2013, season September 2013 through April 20, 2014, the following divisions used the below percentage of ice:

- Rep Teams 58%
- H/L Teams 25%
- PWHL 6%
- Sr. H/L 4%
- Development Stream 1%
- Fundamentals 1%

The cost of ice this year in Barrie was \$207.10 per hour. There will be an increase in Barrie fees this year.

Arenas used were:

- BMC 1 pad
- East Bayfield Community Centre 2 pads
- Allendale Recreation Centre 2 pads
- Holly Community Centre 1 pad
- Eastview 1 pad
- National Training Rinks 2 pads
- Innisfil Recreation Centre 2 pad

- Lefroy 1 pad
- Nottawasaga 1 pad
- Thornton 1 Pad

Looking ahead to the 2015-2016 season, we've added a fourth bantam team and I'm not yet sure how, or if this will impact ice allotments; we managed to add a 3rd Atom team last year with minimal impact.Every Rep team went over their allotment of ice with the exception of 1 team, some were able to add as much as 10-15+ extra hours.

I've submitted our ice request to the City of Barrie with the request of 80 hours per week in Barrie. The amount of hours I requested per week is sufficient enough to have all our teams, (PWHL, Rep and H/L and DS), attain their required amount of hours per week on City of Barrie rinks. Unfortunately we don't always get what we request and I expect the allocations to be similar to what we received last year. This means the BWHA will end up going outside to find additional ice to fulfill our requirements (Stroud, Innisfil, Nottawasaga, and Bradford).

New web site implemented last season was a success, eliminating any possible duplication of ice assignments. Still had some minor issues with contracts that caused some minor headaches.

Thank you to all the coaches and managers for making my first season as Ice Scheduler a successful season and I'm looking forward continuing the improvement of our scheduling processes in 2014-2015.

It was our pleasure to be part of a strong BWHA Executive this past season. The BWHA Executive was collaborative, challenging, energetic, resolved and decisive in their approach on all issues and initiative over the 2014/2015 season. It is due to the efforts of this executive, along with our association's volunteers (HL / Rep coaches, managers, trainers, on ice helpers, etc) that our organization will continue to strive and be successful. It is our hope as an executive, that through these efforts, the BWHA will become a stronger and more developed organization moving forward and a great place for girls of Barrie and surrounding regions to enjoy playing hockey.

During the 2014/2015 season, the Directors of Apparel & Equipment (Sr. / Jr.):

- > Ordering of all Jr. & Sr. HL team jerseys/socks by early February 2014 (completed by Dave M.)
- Supplied BWHA Jr. & Sr. house league with socks/jerseys/pucks/pylons/goalie gear by mid September 2015
- Worked with Katie Bailey (Director of Senior HL) Senior HL Champion T-shirts in March 2015
- Worked with Gary Reid (BWHA President) to have sponsors names applied to the 2014/2015 HL jerseys.
- > Dealt with the house league coaches to supply & later collect pucks/pylons/goalie gear
- Throughout the season we sold off some old stock of goalie gear & many used jerseys
- Supplied all 4 BWHA DS teams with jerseys & socks (Novice/Atom/PeeWee/Bantam)
- All Rep team apparel & equipment orders were placed by May 31st, 2014
- Successfully supplied 95% of the rep programs with their team jerseys, C's & A's, socks, warm up suits, bags, practice jerseys, name panels, sponsor panels, tryout jerseys, pant shells, hoodies & custom jerseys by September 1st, 2015.
- Ensured the remaining 6 reps teams cycled out the old style rep jerseys and were replaced with the new style rep jerseys. (as per Dave Marchard and Mario Liguori report from 13/14)
- Now in the 3rd year of the initiative, we enforced mandatory navy pants or shells for all rep players, along with Navy helmets and Navy coloured gloves.
- With the addition of a 3rd Atom rep team in 2014/2015 an old style set of jerseys was held back for use in the 2014/2015 season. As has been tradition in retiring old jerseys, the 3rd Atom team was given the Away set of game jerseys to keep. They were also offered to purchase the home set at \$5/jersey. Many did purchase the home set and the remainder were returned to the BWHA and added to the retired rep jerseys for future sale.
- Ordered new style rep jerseys for the Atom 3 team for the upcoming 2015/2016 and with the addition of the 4th Bantam team, did the same so that all BWHA rep teams are now wearing a consistent team jersey for all teams in all divisions.
- Throughout the 2014/2015 season we worked with Kevin Anderson (BWHA Accountant/Bookkeeper) to track all of the team and individual BWHA apparel/equipment.Successfully billed rep teams for their pickup of team orders in September. Continued with the implementation of rep team apparel tracking on Google Drive, to allow sharing of orders with team and office staff.
- Worked with Casey Thompson (Director of Rep) and Ian MacLean (Director of Jr. HL) to distribute/collect HL evaluation jerseys



- Revamped the sets of Rep evaluation jerseys for each division (Novice, Atom, PeeWee, Bantam, Midget & Intermediate).Distributed these sets to the 1st team in each division, along with a tracking document that was then passed down to the next team in each division.Ensured accurate return of all Rep evaluation jerseys and tracked payment for any missing jerseys in the sets.
- Introduced Pink Rep jerseys for Novice, Atom, PeeWee, Bantam and Midget teams to show their support during Breast Cancer Awareness month. This was a very successful initiative.

Season Highlights:

DIRECTOR of ICE SCHEDULER REPORT

For the 2013 – 2014, season the Barrie Sharks used approximately 1986 hours of ice. Of which:

- 268 hours were at Innisfil, Lefroy & Stroud
- 97 hours at NTR
- 49 hours at Nottawasaga
- 7 hours were at Angus
- Total of 421 hours (21%) of our ice allocation was non City of Barrie ice (up from last year of 16%).
- An additional 342 hours were used for Sharkfest

Looking ahead to the 2014-2015 season, we've submitted our ice request to the City of Barrie with the request of 80 hours per week. The amount of hours I requested per week is sufficient enough to have all our teams, (PWHL, Rep and H/L and DS), attain their required amount of hours per week on City of Barrie rinks. Unfortunately we don't always get what we request and I expect the allocations to be similar to what we received last year. This means the BWHA will end up going outside to find additional ice to fulfill our requirements (Stroud, Innisfil, Borden and Nottawasaga, and Bradford).

As we move into the next season we have a new association web site that was initially brought in solely for the purpose of streamlining our scheduling efforts. However with the launch of the new site we have seen other improvements as well.

Starting with the 2014-2015 season all schedules will be consolidated on the new BWHA Association website including:
