  - a. Approval of the following motion through special resolution, "Be it resolved that the members approve the proposed ONCA compliant bylaws for Exeter Seaforth Ringette Association as presented on September 7, 2023."
- 2. Audit Process
  - a. Approval of the following motion, "Be it resolved that the members approve the minimum financial reporting requirements permitted in accordance with the Ontario Not-for-Profit Corporations Act for the current fiscal year."
