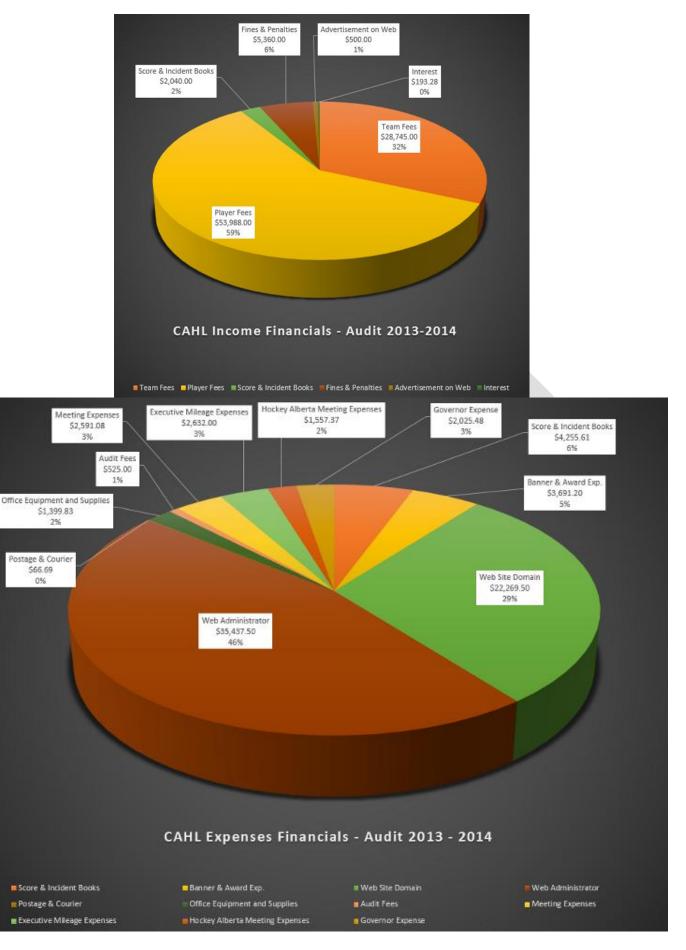
- Invoices are outstanding for Team fees, Fort Macleod and Siksika must pay there invoices ASAP. Please see Shannon right away.

Motion to approve the audited 2013 - 2014 Treasurer's Financial Report by Cochrane, seconded by Nanton. Carried.

Old Business:

- CAHL Marketing and Advertising Coordinator Role. Interest has been expressed from a person in Cremona. Doug has been busy and has not had time to meet with her. Will meet with her as soon as possible for further discussions.
- Suspensions on the Website. Jodi is collecting them and can generate reports if required. Goal Line is also looking at some software changes to make this work better for us.
- Website does not show Bench Minors it shows them assigned to the player who serves them. This will need to be fixed in the off season so it is properly applied to the coach or bench not the player. Currently player # "0" has been setup on each team and called Bench Minor so these can be properly recorded and not be added to another players totals.

Governor in Chief Report:

- Fair Play points or Sportsmanship points (FP on the website) are not working very well on the website. The Governors have tried to keep them checked but there could be issues. As these are very important we are asking the Team Managers to check their games and make sure the website is correct. The Governors will make sure the final weekend of the regular season is correct, but all the other games up to and including February 8th need to be confirmed by the Team Managers. The deadline will be February 8th games so any errors need to be sent to us to correct. After that any errors found by the teams after that time will not be considered for changes. Make sure the Team managers get this done.
- Banners will be ready for the March Meeting. All governors must attend to pick up and sign for their Banners.
- TBA Games there are still some not scheduled and people are being difficult. There are 5 weeks left in the regular season, Directors will be notified to start helping out in getting these scheduled. These need to be done ASAP.
- There were many 5 minute penalties listed that did not have the 10 minutes added for the Game Misconduct. Keri has corrected as many as these as she found. All 5 minute penalties will have at least a 10 minute misconduct added to the penalty time on the player's stats. If you see anything that is not right let your governor know right away. Let us know the errors and we will get them fixed.
- Jodi helped out with the issues the data entry people are having with goalie stats. They are missing step # 3 where the goalie stats are assigned a N/A, Win Loss or Tie. This must be added for each goalie listed on the team. Please let your data entry people know.

Governor Reports:

Novice Lead - Craig Parascak

- The only concern so far is the T4 Canmore team that was having a tough time of it in their tier. They were given the opportunity to pick between staying in the league or withdrawing. They chose to stay and continue to play in the division and we have not heard of any issues with this since.
- Generally going well without much issue. Working on FP points to make sure they are Ok. Not as much feedback from the Governors as he thought he would get around schedules, game changes and game issues.

Atom - Keri Drennan provided the Report

- Still waiting for Lethbridge T2 to schedule a TBA and she is having lots of trouble with it.
- AT5 FP Points are really out of whack, she is working to get them accurate again.
- Only 7 players have had suspensions this year which is good for Atom.

Coffee Break - was not taken to allow for other CAHL Business at the end of tonight's meeting.

Pee Wee - Allison Arsenault

- Few remaining games that need game change forms completed.
- TBA's are all scheduled
- There are several teams with major penalty minutes, further discussion will be taken on this matter for these teams after this meeting tonight.
- Overall things are going well, good group of governors to work with.
- FP Points are behind the group now so it is good.

Bantam - Ryan Robertson

- Bantam has been going well.
- Three teams have > 300 penalty Minutes, to be addressed. Chestermere T2, Medicine Hat T2 and Airdrie T4. A warning will be sent to them shortly.
- There are a few players at or near the 75 minute mark and will see some time off.
- Bantam has had 14 minor suspensions, 12 Checking From Behind Majors, 10 of the Rule 9.2 penalties, 3 match penalties and 3 gross misconduct penalties.
- The Goalline learning curve has been a bit of a challenge but improving.
- TBA's are all done.
- FP Points are all pretty much up to date
- Lots of 5 minute major penalties with no 10 minute game misconduct. Keri reminded everyone that these are being added when identified. This is an education issue, remind people that it applies when possible. This should be reminded part
- Ref Reports are hard to read and not very well done. This makes it hard.

Midget - Shelly Javorsky

- Concerns about penalties, a Chestermere Midget team is at > 500 penalty minutes, Shelly will send a note out to the Governors and have them remind people that this is not good. Note: for interest sake, the record for Midget Penalties is over 2000 in one season.
- There has not been a lot of fights, T4 is worst tier for PIM and misconducts. Overall a fair bit of disrespect towards the ref's out there.
- There is a lot of stuff happening at tournament, which carries over into league play. Directors, take a look at your teams and their penalties and then send a note to your teams about it.
- This tier will be checking the PIM's and keeping a closer eye on these numbers.
- A lot of coach 9.2's have happen so far this year.
- The Midget Governors are doing a great job.

Doug will send a note off to the Ref Associations regarding the poor write ups to address the concerns mentioned tonight. Directors need to go home tonight and talk to your own associations and remind them we need to get better legibility in the Ref paperwork.

Directors also need to remind the teams that the game sheets must be readable and reflect the times, dates game results and who actually played the game. If they do not get better we will start fines to people for this.

New Business:

• 2015 Applications to become full voting members - A letter was received from Redcliff formally requesting they be made a full voting member of the CAHL.

Redcliff Representatives were asked to leave the meeting room while a discussion of their request was completed. A short discussion was and a motion was approved to make them permanent voting members of the CAHL.

NOTE: NOM # 16a and b were presented and the membership had the option to select 16a, 16b or refuse both options.

There was a lengthy discussion and possibly some confusion around what direction the discussion took. Some people said they liked version 16b, but did not make a motion.

After some time and further discussion, a motion was made by Didsbury to motion that 16a be made. It was then Seconded by Duchess closing the discussion on this topic.

The Executive then rescinded 16b from the 2015 Notice of Motions list.

• FYI - Recently, on more than one occasion associations have let us know that they have had information and documents provided to them from the CAHL and they were pointing out we were not following our own bylaws, rules and regulations.

These documents were found to not be ours but were labeled the CAHL. In the last

instance the CAHL was the Central Algoma or Algonquin Hockey League a house league in Northern Ontario.

If people come to you with documents and complaints make sure they explain and show you where they got the documentation from and let us know if you need any help authenticating the material.

 2015 Applications to become Members of the CAHL - No Applications were formally made at tonight's meeting. We have been contacted by Innisfail, Bow Island and Foremost regarding potentially doing so.

A lengthy discussion was had about distances travelled and geography of the league area. Many points for and against more teams were expressed and it was pointed out that the CAHL's recognized success is the standards we offer for accurately placing teams into competitive situations.

Motion to adjourn the meeting made by Cremona, seconded by Hanna.
