Discipline Committee update- Brian Monkman

- Brian welcomed and introduce Connie Anderson Discipline Coordinator Zone 6 from Hockey Alberta
- Coach suspensions are escalating and seem to be happening more than player suspension. Brian Reviewed the PT1 incident involving a coach and a referee. Associations need to discuss coach behavior with their coaches as this unacceptable behavior.
- Total suspensions to date are 614 suspensions for 1059 games in suspensions
- Team Members signing the game sheet need to be carded to the team. Teams can either card the manager or have one of the carded officials sign the sheet. If this is not done properly the team is playing with ineligible roster.
