Old Business:

Survey Phase one Results- Terry and Danny reviewed some of the results with the directors very broad based. Shots on Goal Tracking- In the handbook shots on goal are requested to be done. The shot tracking is not happening on a regular basis and should be. Terry asked the Directors to talk to the Managers to make sure we are tracking this for the rest of the season as best as we can.

Ice Availability and Game Changes- There is a super shortage of ice with provincials coming up that the CAHL has seen already. When rebooking a CAHL game for a provincial one please make the effort to reschedule the game at the same time.
