

## CENTRAL ALBERTA HOCKEY LEAGUE Executive Memorandum

February 8, 2019

To: All CAHL Member Association Members and their Pee Wee T5 Teams

Re: 2018–2019 CAHL Pee Wee Provincials update # 4 Playoff Format Announcement

As presented and the results of the draws made at the Feb 4<sup>th</sup> CAHL meeting the following page shows the draw, durations and who has home venue in the final series.

## Playoff format requirements this season:

- The team or teams moving on to the T5 invitational Tournament will be picked by the CAHL Executive. We are still waiting for confirmation from the other Minor Leagues on how many teams will be coming to the tournament in Hanna.
- All Playoff series will be either best of 3 games, 2 game total goals or final round robin series to complete this
  year's playoffs. All durations must be followed as shown in the following descriptions for each tier. This may
  mean some of the playoff series must be completed each weekend or by the date identified. There is very little
  choice due to the time shortage imposed on us by Hockey Alberta.
  - It is critical teams commit to arranging ice for the games as they appear in the following pages as soon as possible even in advance of the previous series determinations.
- For each series that is listed as 1 weekend long, the teams must either agree to a 3 games series or a 2 game total goals series (as per identified Hockey Alberta Minor Regulation rule 9.2 f). A 3 game series will only be approved should the teams have ice booked and agreed to before the Wednesday night before the series is to start. Both teams must have ice booked to play 3 games Friday Night to Sunday Night with both teams agreeing to the schedule.
  - Should Game Ice not be available for the Team with Home Venue then they must provide suitable ice at another facility nearby the original game location within a reasonable time frame.
  - Any disagreements or failure to get a schedule agreed to between the teams will be forwarded to the CAHL Vice President to resolve as per the CAHL Game Regulations rule Section 5 part p).
- For any final series round robin play, we expect it follows the draw for Home Venue as well. So the team that has Venue for all of playoffs is Team one. Team 2 has Venue against Team 3 only and Team 3 has no home venue awarded. Team with the best record against the other teams wins. The game schedule proposed is:

## Tie breaker decisions for 2 or more teams:

• Should a tie happen in any round robin play following Hockey Alberta Regulations Section 9.3 parts G) and then part I) will apply to resolve the ties at the end of the round robin play. In these cases, the CAHL Executive will be involved in this discussion and decision.
