- Changes to Hockey Canada Rule Book all rules have a new number this season.
- Now a rule for injured players on the bench (Rule 2.2) A player who is injured can be on the bench but must be listed on the game report and have the minimum equipment of a helmet and neck guard.

Question from Airdrie - Does a suspension from last year in SCAHL carry over to CAHL? Yes, if it is a Hockey Alberta suspension.

Question from Innisfail - Can a coach serve a suspension on another team? No, they must serve the suspension on the team they were suspended from and cannot be on another teams bench until it has been served.

Old Business

Committee updates - Realignment committee, Rule 11 committee and Hockey Alberta Maltreatment Process, Inter-league play committee

- Realignment committee (Ryan Robertson) Tried moving a few teams around last season that did not fit in their tier. Difficult to integrate teams without causing issues. Let Ryan know if you are interested in joining the committee.
- Rule 11 and Hockey Alberta Maltreatment Process Update will be sent out to Hockey Alberta members based partly on feedback from this committee. Hockey Alberta will be investigating these this season.
- Inter-league play (Melanie Jackson and Ryan Robertson) Working with other leagues and Hockey Alberta on this committee. Melanie will be the CAHL contact and representative of U13&U15, and Ryan will be U11&U18.

Governor in Chief Report (Tracey Walker)


- Governor information and training night September 29th in person at Strathmore Civic Centre @ 7pm.

Question from RMAA - If teams identity themselves as a certain tier or strength, can they still move down if they don't fit? Yes, they can.

Question from Olds - Is it the same process for U15 for movement? Yes, it is.

U9 update and affiliation (Amanda Hatto - VP for U9)

- Please take this information back to your association.
- Travel distance maximum is 1 hour and 20 minutes.
- Competitive compatibility for our A division.
- 20 games per team on average.
- Will be using electronic game sheets this season on cahlhockey.ca
- There will be a coaches/managers training for how to use the app in October.
- Only 2 tournament/jamboree requests per U9 team and are encouraged to use the Hockey Alberta recommendations of blackout dates. Blackout dates need to be submitted by October 29th.

- Recommending 9-13 players per team. If there are larger teams, extra players can practice on the other side while game is going.
- If your association has 2 teams, they can play each other.
- Please assign a colour if you have more than one U9 team in CAHL.
- Season starts October 29th until mid-March.
- November 11-13/22, January 6-8/23, and February 17-20/23 are your blackout dates.
- First 2 weeks of play will be out mid-October and we will be shuffling teams if needed.
- Teams are allowed 2 game changes per season.
- All this information will be sent out to members.
- Affiliation is not allowed if teams are not following the Hockey Alberta rules for "Intro to Hockey" as per Hockey Alberta.

Question to members - What can the league do to ensure MHAs are complying?

Motion #2022-04 from Raymond if you do not have a U9 team in CAHL they cannot affiliate. Seconded by Hanna.

After member discussion, Raymond amends their motion that if the team is not in the league already, associations will need to declare that they are following Hockey Alberta rules before affiliation is approved.

More discussion is needed here on how associations will be declaring.

One abstained. None opposed. Motion carried.

Review of Communication Protocols and Complaints procedure

- Quick reminder of our process. We want to make sure everyone is using the 24-hour cooling off period for complaints or issues.
- Any time a member would like to issue a complaint, must be signed off by President or CAHL Director. It will be forwarded to VP
- If you are unaware of the communication protocol, please check our regulations. All directors can speak to anyone on the executive. Please remind coaches and managers and parents to go through their director.
- Associations will be fined for not following protocol.
- Any participant is allowed to submit a complaint within the league. Please ensure complaint form is filled out properly and signed off by CAHL director or President. No anonymous complaints.

Weather related game issues

• Teams must follow the procedure on weather related issues. Teams make the decision with the help of the CAHL directors from both teams. Please refer to the game regulation manual. Both teams will share any costs associated. If you are a no-show team, fines will apply. Please communicate this with your teams.

Notice of motions ongoing

• If you have something you want to get motions ready to go, you can submit throughout the season instead of just at the end.

Open discussion/questions

Question from Irvine - When affiliating, do you have to approve them every single time? Yes, every time by filling out the form. No blanket approvals.

Request from Irvine to have affiliation approvals happen faster. Had trouble with response from league last season. Tracy (Governor in Chief) said to email or call her directly if you have issues.

Question from Irvine - We have one team in CAHL and one in city league. How do we get approval for affiliation? Submit all players at once on form (affiliation approval form for all players from outside of the CAHL - on Forms page) to designated executive.

Question from Vulcan - Last year there was a lot of discussion from teams about distances and cost of travel. Will there be another vote on that? It would be a notice of motion you would have to submit. Please review the current regulation and let us know if you need a hand in creating a notice of motion.

Question from Chestermere - If our U13T1 team does not fit, can we still move them to tier 2? Yes, you can.

Question from Lacombe - If we drop down to a tier 2, do you keep the same ice? Yes, it stays with the team.
