4. Budget

5. CDLA Winter Camp Proposal

CDLA received a proposal from Al Haughton and Crystal Cleach to set up a Winter Camp for PeeWee and Bantam development. Al is prepared to coach the camp for free. The are requesting CDLA to get the permit, book floors and do administrative work. The idea is to run it on cost recovery basis at the Soccer Centre. November to March. 7. TIERING PROCEDURE

Keith presented a proposal to revised the tiering structure for PeeWee to address the competitiveness concerns experienced last season. Two main features were to:

- a. Add a new A2 division which could contain second A teams from larger clubs and, where appropriate, A teams from smaller clubs.
- b. Give clubs greater discretion in evaluating their teams' likely levels and place them in an appropriate level of competition.

Clubs are asked to review the proposal with their Boards and membership and the proposal is otherwise tabled for consideration at the December Board meeting.
