**Canada Day report** - Soccer centre has raised the vendor fees substantially this year. It used to be \$25/day for a table and now is \$100, I have advised the soccer centre that this will likely price some of our vendors out of attending

- Currently we have 14U and 16U female teams from Cali\*lax. May have a 16U team from Saskatchewan. The Fury have indicated that they are able to commit one 16U team and possibly 2 14U teams. We have not been able to attract 12U female teams over the past few years. If we are not looking to

run the 12U female division, we could look to add an additional division perhaps in Novice for tier 2 or 3? Or add additional spots at some of our other age groups. It would be easier to make the decision now on 12U than wait. Please let me know.
