# 6. RIC (ARLA)

- 1. Alberta currently has 196 officials (40 level ones & 64 entry level)
- 2. If there is some form of development funding they would want to move forward with this
  - 1. CDLA requested that RIC bring a proposal with a plan and the data.
- 3. There are returning officials but the guesstimate is that they are down 200 officials
- 4. Registration opened later than in the past first sessions are less than one week away NOT a lot of notice
- 5. Q. Are there exit interviews when officials leave? No
  - 1. Stated that the reason 200 officials left is because of negative behavior towards them
    - 1. 100ish planned for Calgary for this season
    - 2. Our feedback is that they do not get enough shifts to cover their costs
  - 2. Based on the data, CDLA would like to support the challenges around retaining officials, have asked OIC to present ideas
- 6. Q. What can we do to help support retention
  - 1. Suggestion was to have members follow the Dare to Care program
- 7. Q. Sabrecats were offering to give a mentorship opportunity and initiatives to offer support for getting evaluators out and a space for mentorship to happen and be fostered at their TImberfest Tournament last year and it was not followed through with
  - 1. If we can try having the Tournaments be a space for mentorship to happen, they would appreciate the offer and are hoping to make change
    - 1. Tournament ideas Timberfest & High River
    - 2. OIC will send an email to Melinda so that the information can be sent to clubs
- 8. Need data to be able to help support at the end of the day we are all here to help and have the same invested interest
- 9. Assigning games
  - 1. The km area is set on the system, so it is not always their ability to dictate where a ref goes as it could be that there are no other



officials closer to take the shift

1. OIC wants to build more of a foundation for the newer officials as that will help support the betterment of all officials

# 11. Sign up Process
