#### **President: Stewart Dumont**

- Extended a large thank you to all the board members for their ongoing commitment and work they have done throughout the season for CRMHA.
- At the VIAHA meeting there was a discussion about the T1 format with four T1 teams. With regard
  to the T1 teams in the south, vote passed to continue with current format and host associations.
  CR and Comox were excluded from this, and will have to figure out what it looks like (Comox is no
  longer considered T1 by population). The T1 teams will not be able to have tryouts until after
  August 17th. Tier 1 discussion will be ongoing.
- There are indications that the VIJHL will be moving out of Hockey Canada, which will impact U18 teams. If you go with a junior team, and you get cut, you will not have anywhere to play.
- Discussion about our House Tournament rules. Our tournament rules are set, and they have been used successfully for many years. If there is a question around tournament rules, people should connect with tournament coordinator, or Tamara (not google rules to use).
  - Period points do need clarification. We started using them because we had a tournament with 12 teams and the math to figure out rankings was extensive. Action plan: Review tournament rules and the role, if any, with period points.

# Referee in Chief: Jacqui Harrison

- Officials had a great season. There will be a wrap up on April 6th.
- There was a lot of great mentoring this season.
- We had 61 officials to at the start of the season, but were down 4 after December.

- Currently there are a couple of player injuries.

## **Equipment Manager:** Maury Tyre

- One stop goaltending is moving to CR.
- Next season we need access to a full (half-sheet) ice practice time to develop our goalies (used leisure ice this year).
- We need to work on goalie etiquette during practice with our players for goalie safety.
- At Goaltending meeting in Victoria, it was shared cost of goalie coach is about \$150/hour.
- Development teams always take the tyee jerseys when they play a tournament. We went away
  from using the tyee jerseys for the all-star teams because we were accused of sending the rep
  team to a house tournament.

#### **Female Hockey Development:** Chad Braithwaite/Jami Harris

- All 4 Hurricanes teams placed second in playoffs.
- Coaches need reminded not to play players if there is a chance they are suspended. Need to wait for the suspension notice to be sure.

#### Charitable Gaming Co-ordinator: Sue Couture

- \$89 000 has been raised with online 50/50 raffles since over the last 2 seasons since February 2023.
- Update: we can do one Class A license for the entire season as long as we do not gross more than \$250,000. We currently have the correct financial procedures (i.e. audits) that we do not have to change our procedures.
