2023-2024 Season

REP - Central Alberta Hockey League (CAHL) Programs

The REP program through CAHL is competitive hockey for U11, U13, U15, and U18 aged players, that involves travel to other southern and central Alberta towns. The REP program is tiered, and players go through a competitive evaluation process to be placed on tiered teams according to skill level. The number of teams in a division will be determined by registration numbers, skill level, and past attendance. All families will pay the initial fee when registering, and if rostered to a REP team in the fall, will pay the REP fees before October 31st, 2023. Evaluations are held from mid to late September.

Full Attendance is expected on all REP teams. Attendance will be documented, and at the coach's discretion, players with poor attendance may be subject to team leadership-based discipline for portions of games or full games. CMHA has the right to remove any player outright from the roster or redistribute the player to another league for attendance and/or other disciplinary issues.

- There will be two practices a week** in Canmore, Banff, or both. Games are played once or twice a weekend for up to twenty-four home and away league games.
- REP Programs include a power skating session one morning a week, which is included in the program fee.
- U11 players will have 4 prep skates prior to evaluations as per Hockey Alberta's U11 Pathway, that are included with registration. Please see our Camps/Clinics page for more information.

***The practice and game amounts listed above are approximate and are subject to change at the discretion of the CMHA Board. Practices may be cancelled/rescheduled due to holidays, facility closures and Eagles Junior A home games. Some practices may take place in the mornings, in the evening and in Canmore and/or Banff.*

Evaluations for REP Teams:

If your child wishes to try for a REP hockey team, you must indicate that during the registration process.

The goal of the evaluation process is to group similar skilled players together, in an unbiased fashion, to maximize development of the individual player.

All players will initially evaluate for skills (U11-U15) or gameplay (U18). Based on those initial evaluations, CMHA will determine number of REP teams per division and maximum team sizes. A review of potential transitional players from REP to the RHL program will occur. At this point players being transitioned to the RHL will be officially notified.

Remaining players will participate in gameplay evaluations. Based on the outcome of the gameplay evaluations, CMHA will determine any further player transitions to the RHL, and those players will be notified. After the Evaluation sessions are complete, parents will be notified via email of a possible coach's skate and then of their child's team placement.

Please note that CMHA aims to introduce a skills program for redistributed REP players as an opportunity to improve specific skills. These sessions will focus on improving players performance for future REP seasons.

Further information on the evaluation procedure will be available on the CMHA website prior to the start of evaluations.

CMHA Season Schedule Information

The season for REP/CAHL, RHL, U9 and the RMFHL begins in September 2023 while the U7 Programs begin in early October. The season will conclude in March 2024 for all programs. **The season schedule cannot be released until teams are determined** and the Town of Canmore and Banff allocate ice to CMHA. Evaluations for REP teams take place mid-end of September.

No team shall receive ice time for exhibition games or practices after March 1, 2024, except for in the following circumstances:

- Teams that are still engaged in their regular season games or in play-off games after March 1, 2024, will receive their regular allotment of practices until their regular season/play-off season ends. All league games (regular and playoff) and practices will be paid for by the Association.
- Teams that are still engaged in Provincial games after March 1, 2024, will receive their regular allotment of practices until they are no longer participating in Provincials.
- Teams wishing to have more practice times than those allocated above or teams wishing to host an exhibition game, may purchase ice time for games or practices through the ice coordinator, if ice is available.
