I know that the AFLA boundaries were drawn up with the current box boundaries as a guide, so we'd just be interested in having the same mapping adopted for the 2021 season, with grandfathering of players being offered throughout.

Our coach and ref clinics are underway within CALL, and the March 1 deadline is fast approaching.

Our player numbers remain fairly steady so far, with many clubs heading into the schools and youth centres to drum up business. We have several clubs within CALL who are also excited to offer the REC league, which we've been promoting as an opportunity for our new (and mostly hockey trained) coaches to get on the floor to learn the aspects of the game.

The CALL board of Executive remains unchanged for this season, other than our new Treasurer. This is a good thing, since many of our clubs have seen changes in their executive. Continuity is always handy, even when facing new growth!

Our ASG Zone Coaches have been bullied into their positions, with floor times booked throughout our central zone. Our CALL/Red Deer A teams have been chosen and looking forward to their season as well.

CALL scheduling will be complete mid-March, with Team Declaration occurring by March 15th. Our league season begins with the Eye Opener weekend on April 17-20 and will conclude at the end of June. We have been promoting ALA Provincials through all our clubs.
