Red Deer – A teams are final, March 10 will be forming the B teams.

Ruckus – 1 U15 team and 2 U17 teams. Floor time for practices are Wednesdays in Blackfalds and game floor in Lacoka and Blackfalds, looking for some floor in Innisfail and Red Deer.

Stettler -6 registered at U17 not enough for a team hoping to go to Red Deer together.

Sylvan – needing a U17 goalie, hoping for a regulation to be made for a special request for goalies to be affiliated.

Blackfalds – new board members, and numbers are looking good.

Chargers – waiting for hockey to end as that increases the number of registrations to lacrosse. Working on a policy with Rocky View for A requests. The Chargers association is excited to get another year underway. Our registration numbers are already strong, and we predict to be above last year's numbers. With Didsbury arena having no ice for the last half of winter, we are able to have floor time early this year. We are beginning Monday Feb. 24th. We hope this sets our teams up well for the start of the season.

We have had some conversations with Rockyview to develop a path forward to support our A ball players. We hope to bring a proposal to both CALL and CDLA in the near future.

Overall, we are excited to get the season underway and continue to grow our program.

Innisfail – will be splitting up some teams, try it nights coming up. Get on the floor March 3rd. We held a very successful Try It night and are holding a second one on Thursday February 27. 141 Registered players. Tournament/ Festival planning underway. We will commence our season starting on March 3rd at one of our local gyms and depending on ice removal, possibly be moving to the Innisfail Arena the following week

Lacoka – try it nights are coming up, has 4 goalies at the U17 division.

Olds – numbers are looking good, hoping for floor time in Didsbury.
