CHAIR REPORT – Have had meetings with BCSA and TODA. Lots of misunderstanding on how it was to work. TODA is the new District with Frank Rennick as Chair and has been good to deal with. DISCIPLINE REPORT – nothing to report

CLUB REPORTS:

KUFC – Had some snow on the dome. Hoping tournaments go back to normal. Look forward to outdoor season.

RYSA – Hired an Administrator and registration is live.

<u>OFC</u> – in handout. Need to make it clear kids can play where they want and get more training if they want. No one is interested in poaching. Have extra coaching staff as another option for Clubs. KYSA disappointed with comments on OFC's post bout joining COYSA. Can't control comments on social media. Need to move forward from the past.

<u>LCYSA</u> – Talking about Ice Breaker, sponsorships. No longer using WhiteCaps. Question on coach training: it is now Clubbased / organized.

KYSA – Have not renewed WhiteCaps contract. Hired a TD: Drissa Bouare.

OMYSA –Reaching out for sponsors. Doing some work with KU. Grassroots house league soccer.

WYSA - no report.

BUSINESS: CARRIED FORWARD / NEW BUSINESS

<u>Potential Player Shortages</u> (Carl) – OMYSA is going to struggle U14-18. Do we reach out to other Clubs? At Declaration, all Clubs work together. Maybe look at having "pre-declaration". Admins should be at declaration.

COYSA Portfolios (Social Media, Sponsorship, Tournaments, Indoor)

- Indoor is a lot of work, as much as a Club. April will head and can have a committee of non-board or non-soccer people. Maybe hire someone? What about Clubs entering teams? Wouldn't be fair or competitive. 30% don't play outdoor. Many coaches don't know how to coach. What about two levels? Don't have enough time and

can't get more. What if we did hire someone? What is the cost? Maybe one of the admins. Add it into budget and registration. Let's head in this direction.

- Social media do we continue or do we leave to Clubs? Will only post if Clubs ask.
- Sponsorship is for indoor, Kelowna Cup etc. April has a lead and Jason S will help. A sponsor for new referees to pay for gear would be great. Jason F had a connection.
- Tournaments don't plan until we know about COVID.

<u>CSL update</u> – Met with Leon from the Canadian Premier League that's coming in. They want COYSA on board as they think that's how to put spectators in the stands.

Administrator pay review – Administrator left the room and returned after discussion.

January 13, 2022 Motion #1107 It was moved and seconded to increase the Administrator's salary by 5% effective January 1, 2022. Carried by unanimous consent.

January 13, 2022 Motion #1108 It was moved and seconded to annually review all COYSA paid staff member wages and honorariums at the meeting prior to the AGM. Carried by unanimous consent.

Richard will head up a committee to review beforehand and present to the Board.
