PRESENTATION OF AGENDA

APPROVAL of MINUTES of the May 08, 2025 regular board meeting.

<u>June 12, 2025 Motion #1164</u> It was moved and seconded to accept the minutes of the May 08, 2025 regular board meeting as presented. Carried by unanimous consent.

CHAIR REPORT – Had a couple of BCSA governance surveys that covered challenges, what soccer looks like here. We are different than the Coast. Lucas Castro from BCSA has reached out to provide support; helpful for gray areas in rules.

REFEREE REPORT – written report. Short officials for COYSA Cup.

TOYSL REPORT – written report. BCSA is potentially changing governance. Instead of Districts, more regionalized. TOYDA/COYSA would merge. BCSA would more involved.

CLUB REPORTS:

- KYSA Getting ready for U6 Jamboree. Q: Registered for Revelstoke tournament before fall confirmed; will teams be punished? Will show leniency this year only. Clubs to let Admin know.
- LCYSA No rep, no report.
- RYSA Mini World Cup last weekend. Working on Canada Day Tournament. 98 players registered for fall. Q: On
 referee abuse, where do reports go / is anything done? Clubs are responsible for coach / parent behaviour, so
 Club would deal with it. For repeat offenders, involve Discipline Committee. Abuse has to be in writing by ref /
 witness; not hearsay.
 - Q: Club rep doesn't hear anything from Discipline Chair. Committee only involved if there is a range in the penalty (ie 2-5 games) or there's an appeal hearing. Will ask Discipline Chair to communicate periodically with Committee.
- WYSA Fall registration started. Half dozen teams in CDT. U9 team that moved to U10 are 1 and 1.
- OUFC Looking at color change: light blue for house. Maroon/blue for development/select. Looking for BU14 standings solution with team withdrawn. Starting to gauge numbers for fall.
- OFC Soccer as normal, lots of tournaments.
- PFC Going well. Half dozen teams in CDT. McKenzie Rigg Memorial coming up; a former COYSA player.
- KCITY written report. Business as usual. Governance alignment with BCSA and what they do. Excited for summer camps and programs. Will be playing in the fall.

BUSINESS: CARRIED FORWARD / NEW BUSINESS

<u>Boys U14</u> – team withdrawn after 3 games. General consensus - remove the 3 games prior to team withdrawing. <u>COYSA Cup</u> – June 22. Looking for a Field Marshal/COYSA rep to hand medals/trophies. 8:30am-5:00pm. Jeremy could do some; will send out an email.

<u>Player assessments</u> – Some aren't following the rules/player pathway. U14 and up evaluations have to be done after BCSPL. Motion at February meeting was passed. Below U14 doesn't matter. Will put on COYSA website.

Number of players – The Coast seem to be different than here. Guidelines have a range and areas can choose.

Tournaments do whatever they want.

<u>Season change</u> - KYSA sent in a letter requesting season change back. Admin has not received.

<u>Tiering divisions</u> – Are TDs deciding? Should be a TD conversation on team / player movement. Would really help with lower ages.
