APPROVAL of MINUTES of the January 09, 2020 regular board meeting

**February 13, 2020 Motion #1070** It was moved and seconded to accept the minutes of the January 09, 2020 regular board meeting as presented. Carried unanimously.

**CHAIR REPORT** – written report. City asked about us hosting provincials. There's a financial cost to hosting. It should be KU driven. RYSA is giving a discount for COYSA teams entering the Canada Day Tournament. Andy Stevenson was disappointed BCSA voted down the change to put Associate Members into Full Members. He is very driven. It is their business and livelihood and different than what we are doing. They have bid on a franchise in the new adult league and have asked for support by promoting those games. Senior teams are not part of youth soccer. When the snow melts on our field we'll see what we need to do and RYSA will supply some volunteers.

**TREASURER REPORT** – written report. Everything going well for indoor. Overall will have a bit of a surplus. Assessment fees were billed in January for Q1 and Q2; a couple are still outstanding. Q3 will go out in May and Q4 in August. **DISCIPLINE REPORT** – written report. Indoor BU16 has most yellow cards but there's not players with multiples. **REFEREE REPORT** – written report. We may have an issue with fees as adult leagues are now paying: \$70/\$40. Feel it's important at U18 to match as they play same nights, compete for same refs. Al left the meeting for discussion.
