 - **a.** Fun2 plans for next season proposal from Kyle Goldsmith see below

Create a "Fun 2" program to promote and grow ringette in Chatham-Kent. I believe a program with 20 to 24 children would be a sufficient starting point.

To fund this initiative, I propose a \$35 or \$45 increase to our registration fee. With 125 children currently registered, this would generate an additional \$4,375 or \$5,625 annually, allowing us to add extra ice time to the season.

My proposal is to add a 9:00 AM Saturday morning ice time slot.

This would result in the following schedule for next year: * Monday:

- Kelly Ladd- Expressed frustrations with having two drastically different age groups on the ice at the same time. Looking to help develop each division on their own. She would like to see kids build their ability to play ringette at the FUN2 level while FUN3 is engaging more into game play and drill based learning.
