- Registration fees for 2020/2021 Season:
 - Motion by Chantelle that the CMHA board acknowledges that even though ice has increased by 2% we will be keeping all registration fees the same as the current 2019/2020 season. We will be including a late payment schedule as follows for anyone who hasn't registered and paid by cheque, cash, etransfer, credit card, or payment plan; \$50..00 late fee starting June 1st, \$100.00 late fee July 1st, and a \$200.00 late fee as of August 1st and beyond. All late fees are not subject to financing from 3rd party funding, seconded by Lee All in favor (7), zero opposed, motion carried.
 - o If members are seeking financial assistance it is important they still register and at least select payment plan until funds are received. They must notify Brittany that they have submitted for financial assistance from 3rd party companies.

Recommendations

The majority of development should be carried out in September and October. Scheduling is more difficult then members realize. Our player development team that conducted the majority of sessions consisted of Denis Anderson, Natalie Kehler, and Clayton Krahn. Todd Geddes was used a couple of times. Development people from outside are not interested in coning to Chilliwack due to travel and practice times. I found myself doing the majority of the sessions and it was difficult to accommodate at times due to my work schedule. Kevin Zarillo joined the development team late in the season and did a great job. He is from Abbotsford and is a person the association can use more next season.

Goalie development

Jeff Battah and Grant Rollheiser were our two main guys. Drew Martz and his crew committed to Hope for the season that conflicted with our Monday schedule. Teams did hire these two outside of our development plan.

Recommendations

The player and coach director position should be a full time position and should focus on player development early in the season. This person should development a curriculum for the coaches that concentrates on skill development. The position is very time consuming and there is not enough time to do both at the volunteer position.

Overall I am happy but at the same disappointed we did not get all the sessions in from initiation to bantam.

2nd Vice President – Mark

- By far the most important item that needs to be brought up is that we need a committee to update our bylaws. These need to be completed no later than 30 days prior to our AGM in May, so time is of the essence and in all honesty, I am uncertain what needs to be done. Regardless, we have to get going on this.
- We have 1 appeal that we are currently dealing with, and the details need not be shared at this time but we are in the process of discussing it. Cindy Rhodes and Taya Kuznik are on the appeals committee along with me.
- I have not received any Scholarship Applications yet, but the deadline is March 31.

Initiation Minor and Major – Chantelle
