# **Hockey Operations Committee**

To be chaired by our ice coordinator and 2<sup>nd</sup> vice president along with all the divisional coordinators.

- ★ Would we look at doing this for our players?
- \* Anybody that has ideas please put them forward to the board.

#### **Fundraisers**

- **x** Could we host a dance for parents as a fundraiser?
- This has been done at other associations and has been successful. We have spoken of this as an executive and volunteers would be needed to make an event like this happen.

#### Rep Tryouts

- \* Applications have new language (i.e.  $A1 \rightarrow A2 \rightarrow A3$  not  $A1 \rightarrow A3$ )
- × 26 applicants for 10 positions
- Short list process is trying to avoid having coaches assigned to teams and then their child not qualified for that team. So 3 coaches will be selected for a division and based on their child's evaluation that will determine what team the applicant will coach. The only exception is when we have none parent coaches.
- The two coaches that have been assigned as of now are:

Wade Robertson - Midget A1

Garnet Wendel - Midget A2

- How was the coach criteria evaluated? References and interviews, we were not able to observe coaches. Attendance of coach clinics will become a requirement.
- When will we know the short list? No one will know until the evaluation process is complete.

Al - 4 to 5 days

A2 - 4 to 5 days

A3 - 4 to 5 days

And this will all be done by September 9th.

- \* How many ice sessions for tryouts? This will depend on our numbers in September.
- How will the evaluations run? Evaluators will not be connected to their divisions. Some independent evaluators will take part in this process as well the goalie evaluator is independent. (note: independent does not infer that they are of no relation to CMHA simply that they are a neutral party)
- \* The head coach will have the final say on his last releases (i.e. last 3 forwards, 2 defencmen, 2 goalies).
- Is it difficult to find evaluators? No, there was no problem last year doing this.
- Some associations will have coaches from other associations assist with this process?
- We do not have the money to hire totally independent evaluators.
- We do have the option to move players up until January but we tend not to exercise this right. Safety concerns are the primary reason for late moves.
- ➤ How long will rep evaluations last?

- September 10-12<sup>th</sup> is the rep tournament held amongst the 4 associations, each association will host one division.
- Will the 3<sup>rd</sup> rep team for Peewee and Bantam be development? We will encourage those coaches to take as many 1<sup>st</sup> years but we won't mandate this.
- Depending on the numbers there may be an Atom A3 team?
- \* No division will lose ice time because of this as it was built into the master schedule to begin with.
