

# **SLSFSC Restrictions Exemption Program ("REP") Process**

Dated Effective September 20, 2021

### **Summary and Purpose**

Effective, September 20, 2021, Spray Lake Sawmills Family Sports Centre ("SLSFSC") began participating in the <u>Government of Alberta Restrictions Exemption Program</u>.

All references below to "SLSFSC" include both Spray Lake Sawmills Family Sports Centre (main facility) and Cochrane Arena.

This document serves to outline SLSFSC's process for implementation of the Government of Alberta Restrictions Exemption Program.

SLSFSC shall continue with the REP until such time as the Alberta state of emergency is in effect and/ or Government restrictions are lifted. SLSFSC will continue to follow all Government of Alberta and Alberta Health Services guidance and requirements.

### **Application**

The REP process shall apply to all REP 'in-scope' SLSFSC activities, including, registered programs, drop-in style activities and classes, adult (18+) group fitness classes, adult drop-in activities (shinny), all public drop-in activities for ages 12+ that occur on SLSFSC property. The REP applies to all members and guests of SLSFSC involved in such eligible activities. The REP applies to all private rentals, and user group bookings. The REP does not apply to participants up to age 17, engaged in organized/registered activities designed for youth through either SLSFSC, or any private rental or user group booking using SLSFSC facilities for the purpose of youth specific programming, in accordance with the Government of Alberta and Alberta Health Services guidelines and policies.

## Scope

Effective September 20, 2021, REP in-scope businesses, entities and events must follow one of these 2 options:

- 1. Implement the REP requiring proof of vaccination or negative test result, plus mandatory masking, to continue operating as usual, or
- Comply with all public health restrictions as outlined in Order 43-2021.

SLSFSC is participating in the REP.





## **How SLSFSC will participate in the REP:**

SLSFSC does not need to apply for the REP program but must always follow or exceed the REP requirements, including requiring all patrons/attendees age 12+ of 'in-scope' activities and tenants to provide proof of vaccination (or negative test/ exemption), as applicable.

#### Resources:

#### The REP does not apply to:

- 1. Businesses or entities that need to be accessed by the public for daily living purposes, including all retail locations.
- 2. Employees, contractors, repair or delivery workers, volunteers or inspectors entering the space for work purposes.
- 3. Children under 12.
- 4. Children ages 12-17 who are participating in a SLSFSC registered programming specifically designed for youth.

#### **Proof of Vaccination**

To review proof of vaccination, SLSFSC will require upon entry to any SLSFSC premise:

1. Valid proof of vaccination – paper or digital record showing name, vaccine type, date of administration.

<u>From September 20 to October 25</u>: proof of partial vaccination (one dose) is considered acceptable as long as the dose was given more than 2 weeks before the time of service;

After October 25: proof of full vaccination (two doses) is required

- OR proof of negative test. See <a href="here">here</a> for acceptable proof of negative test.
- OR proof of exemption. See <a href="here">here</a> for acceptable form of exemption.
- 2. Valid photo ID that matches the vaccine record (required for 18+ only)





#### **SLSFSC Process**

SLSFSC will require all members and guests who wish to participate in SLSFSC governed activities to follow the REP and provide such documentation detailed above PRIOR to any participation.

## **SLSFSC Entry Requirements**

At the main entrance to SLSFSC, the Totem arenas entrance, and the main entrance of Cochrane arena, SLSFSC will have staff visually checking proof of vaccination / negative test results / medical exemption until such time that the Restriction Exemption Program ends or does not require such verification. The below outlines SLSFSC entry requirements:

## **Spectators**

There are no limits on spectator capacity with the adoption of the REP. Masking required and distancing between households strongly recommended.
