4. Presidents Report

5. Treasurers Report

- refer to the financial report to see the year report
- \$38 479.95 in equity an approximately \$12 0000 income over the year
- there will be an 3 year audit happening this Spring

- fundraising changes to be made for liquor raffle
- fundraising total was \$18 000 (an increase from last year) with liquor raffle, 2 50/50 and tournament raffles
- ice is the main cost and increases every year (increasing by 5.6 % next year)
- look to continue to increase profit to be able to purchase ice if available (the goal is to be able to upfront pay for ice costs at the start of each season)

- we need to do casino application for future fundraising
- inquired about approximate number of players with funding (approx. 20-25)
- has the league applied for grants in the past (was talked about but not pursued)
- asked if anyone has a connection to a CPWA

A. - B. 2025 proposed Registration changes
 - E-transfers will no longer be accepted for registration. Credit card or Jumpstart/Kidsport funding (application #'s required) at the time of registration only.

- without e-transfers there will be no chasing

b. Registration will open via RAMP middle of May for all previously registered families only. This will be open for two weeks and then general registration will commence.

- social media advertisement will start at open registration time

- fees not set now but could be close to early bird from this year or closer to general

- d. Registration rate for 2025 to be determined still. Update SLSC ice costs will increase 5.5% for next season. Hockey Canada per player rates will increase 40% for next season (see attached). No update on Springbank ice costs at this time.
- C. 2025 proposed Fundraising changes:
 - a. Elimination of the holiday liquor raffle and associated \$30 per player registration cost and simply conduct a 50/50 raffle for Christmas.

Questions/Discussion:

- look to just run 50/50 (2/year) and tournament
- new fundraising manager could come in with new suggestions
- reduction of \$30/player at registration
- a little unclear on expenses/income for fundraising

ALL ACCEPTED to remove liquor raffle

- D. 2025 proposed U14 Division change:
 - a. Move to a U15 Division to match surrounding Communities Cremona, Didsbury, Sundre

Questions/Discussion:

- many small communities do this and we need to match up to them to be competitive
- discussion around how we decide who plays down

- people from each town need to discuss who we have even matched games
- how do we keep our teams competitive
- less than ideal but have to move to U15 to match other leagues
- can we look at running goalie clinics to build skill and investment
- 9. 2025 League Manager Volunteer roles (non-voting rules):
 - a. Seeking volunteers to assume the following 3 roles that would work closely with the Board for the upcoming season.
 - 1. Operations Manager oversees the team managers and communication with parents when needed.

HOCKEY CANADA PARTICIPANT SERVICE FEES

Effective for the 2025-26 season, Hockey Canada participants will notice a change in the structure of their annual service fees that directly support benefits provided by the national governing body, including sport safety and hockey development initiatives.

Participants will pay \$41.41 in service fees next season, including insurance, which is an increase of \$11.68.*

The majority of the increase is related to the participant assessment fee, which has not been raised in over 20 years.

The participant fees will be structured as follows:

- Assessment fee will increase from \$3.00/participant to \$10.00/participant
- Sport Integrity fee will increase from \$2.94/participant to \$4.50/participant
- Hockey Canada Registry fee will be \$3.12/participant
- Participant insurance fees will not increase for the 2025-26 season and remain \$23.79/participant.

We thank you for your understanding of these changes to our service fees for next season that are necessary to ensure the development, sustainability and safety of Canada's hockey system.

*In Quebec, participants will pay \$39.00, which is an increase of \$10.12, as they have a different fee structure based on provincial legislation.
