Appendix A - Reports

Vice President (Josh): I still have 1 discipline case open. The member of the association was suspended for the entire outdoor season due to not completing their requirements and decided to go on the field and coach after he was informed many times not to. The member still needs to provide proof of completing the Respect in Sport course and serve the remaining summer.

By-law committee: Our last meeting was 31 May in which we completed our first review of the by-laws. I will be sending out a revised copy to all the volunteers with a scheduled date for the next meeting.

- b) U7 Director (Danielle): We had a year end party on June 26th with the U5. Everything went smoothly with the bbq and practice. Had parent volunteers come to help with the bbq. I had extended the season till July 3rd. I had a few teams & coaches come to the extended season which was really good. The

season there was a couple practices that were canceled due to rain. I have all coaches bags back from all coaches.

c) U9 Director (Meagan): U9 wrap up went well. I had ordered hot dogs as usual for mini divisions through Hamels, they gave us 200 for free then a great discount on the rest. Sobeys was great too!(Latoya , can we do a Facebook thank you post to Atco, hamels and Sobeys for their support?)

Over all a great season but had a few cancelled practices. We did our wrap up the 25, then extended till July 4 and had a couple teams attend. I had a couple coaches not able to fully commit but other coaches help take over and run games and practices, as well as James who was a big help I am missing a couple coach bags- I will grab them when I'm back in cold lake.

Adult season unfortunately we just couldn't get commitment. Thank you directors that reached out to players, I did have a couple reach out but were unable to commit due to provincials and travelling/ the week night commitment. Melissa has offered the 4 players a spot on the Bonnyville team and I have arranged to meet up with Brittani to get back team kits.

d) U11 (Temporary, Latoya): U11 Wrap up went great the parent vs kids games were a huge success and some teams decided to do other things like popsicles, pictures, medals and certificates this all came out of the coaches own pockets. BBQ was fantastic huge thank you to Cory and Melissa Ellis for doing that and also to Meagan and Danielle for helping them out as my volunteers decided to do a bingo instead last minute. We did have a couple more hot dogs then buns but hamels gave us more hotdogs then we

asked for so the parents are the one without buns. All in all a great season for U11. I have all the coaches bags, U11 youth goalie jerseys and balls in my shed as I collected them the night of the BBQ.

e) U13 Director (Julie): U13 boys koua were 5th place and Cote was 9th place for Lakeland Cup weekend. They didn't make it to provincials, they played great and had a lot of growth as players. Their last day was June 27 with Hot dogs.

U13 Girls got Gold at Lakeland Cup and went to Provincials. They made it 6th place at provincials, they played their best. They practiced till July 6th to prepare for Provincials. They had fun. The girls also had their wrap up party same night as the boys. This is my final report as U13 Director. I will help whomever takes over as Director for U13.

f) Youth Boys Report (Kathy):

U15

• The boys finished their season, unfortunately they came in last at Lakeland Cup and did not qualify for provincials.

• They did attend the Summer Drizzler in Edmonton and came home with silver!

• At the start of the season the assistant coach stepped down, luckily the team manager stepped up and did double duty on the bench.

U17

• We had 7 boys from Cold Lake join the Bonnyville team this year. They took gold at Lakeland Cup and were the provincial CHAMPS and received the fair play award.

• Everything ran very smoothly between the 2 communities, no issues with players or team staff.

• The only thing I am a bit disappointed in is that in all posts by Lakeland on social media they never mention Cold Lake as being part of the team. This is minor but I do believe we should be mentioned as well as we had 7 members join from Cold Lake.

U19

• There was only 1 team within Lakeland at this age, 2 from Cold Lake. They took home GOLD at provincials.

• As far as I am aware there were no issues this season. A few yellow cards for our Cold Lake boys, luckily no reds!

Summary

I do have some concerns regarding coaching staff for the outdoor season. There are weeknight games and the commitment to attend these games has been a challenge. Most of the players had no issues traveling during the week. Thankfully we had Julie and Frank step up to coach the St. Paul game, otherwise it would have turned into a forfeit which would jeopardize the team's eligibility to attend Lakeland Cup.

I feel there needs to be more transparency during registration for the outdoor season stating that weeknight travel is mandatory. I know it is written in there already but feel we need to bring this up before teams are made.

In my opinion traveling on weeknights at the older ages works well, the season is so short already and most weekends are booked with out-of-town tournaments both in Lakeland and the bigger cities.

For the indoor season I know this isn't an issue as games are scheduled on the weekends.

g) Youth Girls Report (Andrea K): Season went well. Provincials was a success but the refs said Cold Lake did it WAY better

U15 BV had 2 of our girls placed 4th

U17 BV had 3 of our won gold

U19 CL won silver

We have wrapped up our regular practices but are looking at schedule a game on the 23rd parents vs kids with some of the RCMP. Frank is also looking at hosting the girls for a season wrap party at his place.

As some of you know I will be stepping down now that the season has ended as the youth girls director but will still be available to help where I can. I'll continue to be the admin on the gmail accounts and am happy to help keep the website up to date. Just send me anything you need posted.

• I will perform observations on coaches and practices to uphold the standard and make sure that the club is not being used as a time waste/day care, in the hopes of growing soccer as a sport in the district

• I will have contacts at ASA and will function as a scout for talent in the Lakeland area in the hopes of providing more incentive for children to participate in soccer activities

I will run more soccer camps through the year which will be another income stream
I will be accessible through the day to CLMSA in the aims of supporting people such as Frank in the day to day running of the club

• My aim will be to grow the sport of soccer firstly in Cold Lake and then the district, into a sport people can play for fun and also competitiveness, with my different outlook on the sport the only way for the club and sport to go is up, coming from a successful sporting background I will do all that is possible to help everyone involved in CLMSA and gain more participants each season.
