- Bantam C coaching change
  - New head coach is Mark Barnes
- Bantam A request for financial relief
  - Manager has sent an email to Ryan requested financial relief for a variety of reasons see Motion #4 below
- Projected 2020/21 teams
  - Projected numbers for next season
    - Midget (U18) 51 skaters and 7 goalies 4 teams roughly assume a few imports for AA team – advertise for Midget A and AA
    - Bantam (U15) 45 skaters and 7 goalies 4 teams roughly assume imports and for AA team – advertise for Bantam AA
    - Peewee (U13) 30 skaters and 2 goalies 2 teams House and a B
    - Atom (U11) 42 skaters and 2 goalies 3 teams levels to be determined later

## **3.4** Coaching and Referees

- Player & goalie development clinics
  - Goalie sessions are done this week if we have more room in the budget Dwight will coordinate more – Executive agreed to plan more
- Tryout plans
  - It was discussed having hired evaluators (e.g. Next Generation or Endeavor) to complete the evaluations during tryouts See Motion #1 below
    - This would allow Executive to receive new feedback on the evaluations



- Policy and conditions would have to be reviewed as to if the evaluation results would be firm or subject to opinion/changes
- The hired evaluators would meet with the association evaluators to train them for future evaluations
- Research to take place to obtain further quotes for hired evaluators
- Tryouts for Peewee and above to take place in the Spring
- Coaching Clinics
  - Hamish has organized a clinic for the HP coaches on January 18 from 9am to 12pm to be run by Bill Bowker – there is no charge for this session – it will be mandatory for HP Coaches and open to all coaches in Cyclones and Kings
  - Renee also provided some information on coach clinics by Next Generation and Endeavor Renee received a quote for approximately \$2200 for two to three sessions
