3.1 Administration

- AGM
 - o Introduction of new Executive members
 - Survey went out to all members regarding the changes in the Policies. Only one response with regards to the changes of having a coach only allowed to be on the roster for one team. Ryan will follow-up with the individual that voiced a concern regarding this change.

OWHA UPDATES:

- O COVID-19 Return to Hockey Framework
 - Review of the outlined stages. Follow the health units direction
 - No sanctioned events are allowed at this time; and no dates have been provided for when it
 may be expected that we can start having sanctioned events.
 - There is a maximum of 10 people allowed due to Social Distancing guidelines
 - The beginning of the year will be more of a focus on skills and player development as it is believed that regular game play will not be happening until January 1, 2021.
 - Dave with the House and Competitive representatives will put together a plan based on the different stages
 - There will be a certification process put in place by the OWHA, we must present our plan to them prior to any sanctioned events. This plan must also meet the health units requirements prior to holding a sanctioned event.
 - Requirements will be
 - Facility screening question Will this be our volunteers that must coordinate this
 or will the town / facility staff be responsible



Executive Meetings June 24, 2020

- Must keep records of who enters the facility during the CPGHA events
- PPE will have to be worn by coaches
- Facility openings there are no firm dates as to when facilities will be opening.
- Registration can happen but no fees can be collected at this time
- There will be no releases of players allowed due to the restrictions
- OWHA is considering a phase approach such as allowing Eastern Ontario to move forward, while the GTA is not able.

Registration System change

- This item will be discussed at a later time as we are not opening registration yet.
- May post a "Intent to Register" so that we can get an idea of the number of players we may have at each level.

- Budget pre-approval of budget is not expected at this time as we are unsure what will be expected expenses this year. Expenses we will have to possibly approve this year is PPE and tryout jerseys.
- Taxes-Variance for 2017/18 season this was an issue with the fact that a 3rd account (Lottery Account) was opened but not recorded on the end of year income statement. No monies was missing. Ben McNeeley reconciled the income statement to reflect the lottery account. An adjustment note was added. He will then file the taxes for that season.
