\_\_\_\_ INITIALS - By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by participation; and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at Cranbrook Minor Ball Association activities and events may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Cranbrook Minor Ball Association Board Members, volunteers, coaches, program participants and their families.

\_\_\_\_ INITIALS - I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death, illness, damage, loss, claim, liability, or expense), of any kind, that I may experience or incur in connection with my participation with Cranbrook Minor Ball Association. On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless Cranbrook Minor Ball Association, its board members, volunteers, coaches, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Cranbrook Minor Ball Association, its board members, volunteers, coaches, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation at Cranbrook Minor Ball Association events.

\_\_\_\_ INITIALS - I represent that I have adequate insurance to cover any injury or illness I may suffer or cause while participating in this activity, or else I agree to bear the costs of such injury or illness myself. I further represent that I have no medical or physical condition which could interfere with my safety in this activity, or else I am willing to assume – and bear the costs of – all risks that may be created, directly or indirectly, by any such condition.

\_\_\_\_ INITIALS - By signing this document, I agree that if I am exposed or infected by COVID-19 during my participation in this activity, then I may be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of any claim for negligence.
