-Discussed- felt an increase was warranted but to \$15 was quite a jump. -Some feedback from last season highlighted a few issues that need to be worked on such as assigning games earlier and requiring more direct communication from refs to the assignor directly when cancelling rather than just cancelling on the app -Carly can change app setting so if an official is cancelling a game with less than three days notice they have to talk directly to the assigner
