# Constitution changes with vote AP/Prov/Fair play- Proposed language for constitution is: FAIR PLAY

Fair play is about the development of skills and character on and off the ice. Fair play is about having players placed in situations where they will grow their skill set as an individual and as a team.

For the U7 and U9 age groups fair play will be the equivalent to equal play with all players having equal opportunity to ice time.

For U11 divisions and upwards, fair play will be at the discretion of the coaching staff based on dedication and attitude of each player and what would be fair not only to each individual player but also taking into consideration the team as a whole.

### **Appointed Players (AP's)**

APs are to be used in situations where a team is needing to fill a certain position on their team due to extenuating circumstances. AP's chosen are those that demonstrate readiness, maturity and capability to play in a higher division. This decision is made by the coaching staff of the team requesting the AP and of the parents of the AP. APs are not to be used when a team has the maximum number of rostered players.

#### PROVINCIAL PLAY

Provincials will be entered into with the intention of putting the best team forward for competitive play. All rostered players, with the exception of goalies, will be given the opportunity to play at some point in the series.

Discussion some wanted 11 and U13 to have equal play time, also asked what the damage is to have equal play time. Some felt that u11 and up is competitive and fair play is what should happen.

Wanting to put kids where there is opportunity to grow.

Chris Stephans motioned to accept all language into the constitution. Al McNabb 2<sup>nd</sup> it Vote was 17 for and 9 opposed- Motion passed.

New business-Exceptional Status Form NEW form to request exceptional status to play in a higher age group. Form on website and must apply. Then executive decide on a base-to-base decision.

Female Co-ordinator Executive-We proposed to have female coordinator on Executive so that when making decisions about girls' hockey they are involved.
