As a member of this team, the player agrees to abide by all CLA, CALL, ALA & CLA rules.

As a member of the team, each participant agrees to:

- Compete intensely on the field, but always conduct themselves in a sportsmanlike manner
- Represent themselves and their team, reflecting the highest standards of Lacrosse
- Respect officials, coaches, trainers, parents, and opponents
- Respect opponents and play fair; refrain from using profanity or illegal tactics
- Respect all rules set forth by CLA coaching staff, tournament/clinic/event organizers
- Respect the rules of the game, and not fight nor attempt to injure anyone on purpose
- Respect teammates by not bullying or name calling in anyway
- Wear the proper equipment and wear it correctly
- Obey laws regarding the consumption and use of Alcohol, Tobacco, Marijuana, and Vapes.
- Remain free of all abusive drugs (narcotics, steroids, Controlled Substances, etc.)
- Understand that there is no tolerance for abuse in anyway

As a member of the CLA, I agree to abide by this Code of Conduct. I understand that conduct unbecoming a member of this team may subject me to disciplinary action, including game suspension and the termination of my participation.

Expectations for Parent Support

- I agree to accept officials' decisions and I understand that verbal abuse or harassment of an official could be detrimental to my son/daughter, the activity, the team, and the league.
