#### President Michael Doerksen:

• Awards - have nominations from all teams except some in U9, U11, and U18. Please have nominations in by March 15th.

#### Vice President Jordan Cameron:

#### **Treasurer Annette Cartwright:**

- AGLC reports received and filled out. Need to be completed by March 24, 24.
- U7 tournament profit-\$8,166.28.
- U9 tournament profit-\$9,132.41. Waiting on all cheques to be withdrawn from all tournament accounts, then I will transfer funds to the technical account. Raffle profits from all the tournaments were already deposited into the small license account.
- 12 teams have claimed their \$500 tournament refunds so far.

- When will we be receiving our refund/dispersal of funds from the dissolution of the NAI hockey league? Have not been given an exact date yet. Some talk of keeping NAI around for another year before dissolving.
- We still have not received money from the PEP camp in the fall of 2023. PEP thought we were set up with Stripe but we are not. They are looking into it.
- U13 Pile Base has to travel to Ft.Mac for playoffs. Do any other teams have to travel to Ft.Mac? We have \$1500 left from the Weyerhaeuser giving fund, from the previous year. We had decided to use this money specifically for teams traveling to Ft.Mac for playoffs. Can we give this money to the U13 Pile Base team to go towards their bus? U15 also has to travel to Fort McMurray for playoffs. Neither team has been able to get a bus.
- Can teams do Rafflebox 50/50's to help raise money for bussing costs? Some worried it will take away from the big organization 50/50.
- This will be my final year as treasurer. Will shadow someone for the 2024-25 season.
