Drayton Valley Minor Hockey (DVMH) Covid-19 guidelines as of September 8, 2020.

Please ensure to read all parts of this document along with the documents listed below with your child as they will be expected to adhere to these procedures. Please be aware that these documents are changing on a regular basis and DVMH will keep you updated with the necessary information.

Screening/Contact Tracing/Safety Precautions

DVMH must track all participants and their interactions on a daily basis. This information must be maintained to assist Alberta Health Services should an individual test positive for Covid-19 and contact tracing is necessary. As a result, rosters are to be kept for each event/activity so there is a record of which individuals were present.

Individuals are not permitted to participate in any activity or program if they answer yes to any of the following questions. These questions are to be assessed prior to any event however DVMH is no longer required to maintain a record:

- 1. Do you/your child have any new onset (or worsening) of any of the following symptoms: Fever, cough, shortness of breath, difficulty breathing, sore throat, chills, painful swallowing, runny nose, nasal congestion, feeling unwell, fatigued, nausea, vomiting, diarrhea, unexplained loss of appetite, loss of sense of taste or smell, muscle/joint aches, headache,conjunctivitis (pink eye).
- 2. Has the person attending the activity/facility travelled outside of Canada in the last 14 days?
- 3. Have you/your child had close unprotected contact (face to face contact within 2 meters/6 feet) with someone who has travelled outside of Canada in the last 14 days who is ill?
- 4. Have you/your child attending the program or activity had close unprotected contact (face to face contact within 2 meters/6 feet) in the last 14 days with someone who is ill?
- 5. Have your/your child or anyone in your household been in close unprotected contact in the last 14 days with someone who is being investigated or confirmed to be a case of Covid-19?

Should an individual answer yes to any of the questions above or become ill during a practice they will be expected to follow the Return to Hockey Procedures outlined in Section 7 of the Hockey Canada Safety Guidelines.

DVMH procedure for documenting attendance and ensuring participants' understanding of the Alberta Health Daily Checklist.

To make this process as simple as possible, DVMH will be utilizing TeamSnap to track rosters for each event/activity. As a result, each participant including coaches will be **required** to log into TeamSnap up to 8 hours before an event and complete a self assessment that will clear the player to participate and document their attendance at the event.

- If the attendance via **Team Snap** is not completed that individual will **not** be allowed to participate for that event.
- If the self assessment is completed and you answer yes to any of the questions you will **not** be able to participate and **must follow the return to hockey procedures.**

An email will be sent to everyone shortly with a TeamSnap invitation along with detailed instructions on how to record attendance for each event. TeamSnap will also be used as the main communication tool for each Cohort group. Please ensure you activate your account as soon as possible as you will need to confirm attendance for all activities prior to stepping on the ice. Please also bring a signed copy of this document and hand it to your coach on the first day or scan and send back to vicepresident@draytonvalleyhockey.com.

In addition, DVMH is following AHS guidance regarding only allowing an athlete to belong to one sport cohort for the duration of Stage 2.
