League must be completed minimum 10 days prior to provincials. League champs will represent at Provincials. Discussion on how to format the league finals. North/South division one weekend, then cross over the following weekend. Top 2 teams come together to play for banner. Or do bracket style. ECAFHL may have to kick in some money to help with this. Nicole advised we do have funds if need be. Suggestion made to just try the new format for U13 this year and see how it goes.
