13. New Business:

- 13.1. Amendment to Fines in the Operations Guidelines (can be changed at any time)
 - 13.1.1. A fine for not complying with all regulations other than what is stated already could be implemented against the offending team of LMA and can range from \$50.00 to \$250.00 as decided on by the ECAFHL Executive Members. All fines will be on a scale system.
 - 13.1.2. A motion was made to accept 13.1.1 by Les Cote, seconded by Jay Hall.

13.2. Amendment to Overage Players

- **13.2.1.** All overage player applications must come from the ECAFHL prior to playing any league exhibition, regular season of playoff game. The application must include all required information listed below (see existing requirements). Overage players that are approved by Hockey Alberta but not approved by ECAFHL will NOT be permitted to pay in the ECAFHL. The discussion on overage players arose form St. Paul Atoms having 4 overage players on their team. They did follow protocol with Hockey Alberta.
- **13.2.2.** A motion was made to add 13.2.1 into Amendment to Overage Guidelines to be discussed at Fall AGM by Dustin, seconded by Scott Forbes.

- **13.2.4.** ECAFHL Executive will contact division teams in each league to let them know of teams that have overage players within their division.

13.3. Playoff Format Change

13.3.1. A lengthy discussion was held on possibly having a new playoff format for ECAFHL for the next season. During discussion it was decided that the new playoff format would remove the underdogs from having an opportunity to play in playoffs.



- 13.3.2. A motion was made by Scott Forbes to keep the current playoff format that is in the Guidelines, to set hard dates for playoffs and to not take the new playoff format. The motion was seconded by Sean Murphy. 13.3.3. Motion carried.

13.4. ECAFHL 3 on 3 Tournament information and discussion

13.4.1. On September 21-23, 217 Wainwright will be hosting a 3 on 3 hockey tournament for female teams only. It will be a 24 team tournament for Peewee to Midget, 8 teams per division. Each team roster must have a minimum of 6 players and a goalie. Tournament is open to everyone. Fee is \$600 by Sept. 1, after Sept. 1 \$750. Players MUST be registered to play hockey for the 2018-19 season. There is a 3 game guarantee with 3 round robin games. Games will be 3 periods, 12 minute straight time per period. Teams can be put together from any association but they MUST be players that are registered to a Minor Hockey Association. Teams are allowed a MAX. of 2 overage players/team. Teams can register on the ECAFHL Website and e-transfer money to the ECAFHL account.

13.5. Website

13.5.1. There have been some concerns with the website (Goalline is now Blue Star). Nicole will continue to update the website for next year and will work on it over the summer. A suggestion was made for Governors to update game sheets, as it may make it easier. ECAFHL will continue with the website for next year and are asking patience from everyone with it. Request was made to register as a team for league online as it would make for easier communication.

13.6. Onion Lake/Frog Lake

13.6.1. Scott Forbes brought up the discussion of Onion Lake and Frog Lake in our League. Onion Lake left the league on good terms, they forfeited their League fee. Frog Lake will have an incentive bond for next year if they want back in.

13.7.1. A suggestion on Governors getting paid was brought forth by Les Cote. Currently, governors receive \$250.

13.8. Game sheet entry and verification on Website

13.8.1. Discussion was held on managers being responsible for making sure game sheets are signed, up to date, and include the # of shots on goal on the game sheet. Further discussion is planned for the Fall AGM and is to include looking into the verification of game sheets being done on the website. Are wanting to have game sheets verified by both managers within 24 hours of a game being played. Home team enters game sheet with both managers verifying. An email reminder will be sent to sign sheet. Fines will be given on a sliding scale if it is not being done. An email will be sent to leagues if it is not being completed.

13.9. Affiliated Players

13.9.1. Scott Forbes brought up discussion on affiliated players and what ECAFHL has in its Guidelines. Currently in Guidelines there is a 2 game minimum with gentleman rule for trusting that the player has played 2 games. The 2 games can be from exhibition, league or playoff games.
