There were a lot of suspensions last season. Overall the amount of other issues the executive had to deal with was down. We contribute the reduction in issues largely due to the changes that were adopted in the operational guidelines. I think we eliminated many of the reoccurring issues with the changes. I will be moving to the Past President a little later on in this meeting. I would like to thank everyone for their support and passion to keep this league growing year over year. We will have many challenges in the coming months at a minimum, but if we are able to think more with a global approach we will come up with workable solutions. Due to many of the restrictions we are currently facing the executive may be forced to stray a little from the OP Guidelines in order to complete a season and playoffs. I look forward to staying engaged with the league in some capacity for years to come.

## 8. Playoff Report:

Playoffs went well. Unfortunately, the PW teams were cut short, but both teams agreed prior to the start that if hockey was to be shut down it was going to be a winner take all night.

- 8.1 This season the Atom's will be a tournament style playoff. There are no Provincials for Atom's this year as decided by Hockey Alberta. - **13.4** One person wrote in (in lieu of the Spring AGM) could the minimum size of a team be increased From ten? This year as it stands right now there are no AP's allowed at all. Open discussion held.
  - -Jill made the motion that the minimum size of a team be increased from 10 to 12.
  - -Shayna seconded motion. Motion carried.
- **13.5** Justin to hold discussion on cohorts and Pod play. What we know about officiating. Season Structure. 3 on 3 or 4 on 4 to accommodate small teams this year? Still waiting on HA to approve, but the executive feels in these circumstances we need to be open to other options in order to work with Associations and do what we can to keep rural female hockey going.
  - -Justin shared teams will be built on cohorts with cohorts being a group of 50 people. Coaches can coach multiple teams (can be a main coach on one team and can help other teams but must wear a mask when helping non-cohort teams). The fewer coaches on the benches the better. Scheduled season begins: Nov. 6/20 for U11and U13 -will be staggered start.

Nov. 16/20 for U15 and U18

Schedule runs until Christmas.

- -Play is 2 weeks on 2 weeks off.
- -Some confusion about Cohorts and Rosters and how they are different. Justin will speak to HA to sort it out.
