Definitions Section 1

- 1.1 Apprentice Coach– is an individual who is under 18 years of age and who is registered with the EYBA to act in the capacity as an Apprentice Coach for a specific team.
- 1.2 Apprentice Manager— is an individual who is under 18 years of age and who is registered with the EYBA to act in the capacity as an Apprentice Manager for a specific team.
- 1.3 Coach is an individual who is at least 18 years of age and who is registered with the EYBA to act in the capacity as a Coach for a specified team.
- 1.4 EFCL means Edmonton Federation of Community Leagues.
- 1.5 Executive shall mean the elected officers of the EYBA consisting of the President, Vice-President, Secretary, Treasurer and the Commissioner. These officers are elected at the Annual General Meeting in accordance with the By-laws of the EYBA.
- 1.6 EYBA the initials EYBA shall mean the Edmonton Youth Basketball Association.
- 1.7 EYBA Board of Directors shall mean the Board of Directors of the EYBA, including the elected members of the Executive and the Zone Directors of the Zones participating in EYBA.
- 1.8 EYBA Discipline functions in the capacity of implementing the discipline procedures and rulings pursuant to EYBA rules as contained herein. All issues of discipline are to be forwarded for review. EYBA Discipline can either be made up of a single commissioner or a disciplinary committee.
- EYBA Executive Director is an individual appointed by the EYBA Board of Directors to fulfill all duties and obligations as outlined in his contract, and all other duties as assigned to him by the EYBA Board of Directors.
- 1.10 EYBA General Manager is an individual appointed by the EYBA Board of Directors to fulfill all duties and obligations as outlined in his contract, and all other duties as assigned to him by the EYBA Board of Directors.
- 1.11 EYBA the initials EYBA shall mean the Edmonton Youth Basketball Association.
- 1.12 FIBA the initials FIBA shall mean FIBA International Basketball Federation.
- 1.13 Fouling Out When personal foul limit is reached, player must sit the remainder of the game.
- 1.14 Import shall mean a released player from another zone.
- 1.15 Minor Officials Minor Officials are valued volunteers. They include the Timer, Scorekeeper, and any other Minor Officials authorized by the Referees, such as Assistant Timer or Assistant Scorekeeper. They are part of the officiating crew of a game and will be accorded the same respect as the on-court Officials. Each team is required to provide one volunteer to complete the duties needed at the score table (Timer/Scorekeeper).

- 1.16 Player means a youth participant who is enrolled and playing within one of the age group categories of EYBA.
- 1.17 Principal Residence shall refer to the main residence where an individual normally resides, and in the case of a player or parent/guardian shall be the residence that is declared and entered into the EYBA registration system.
- 1.18 Released Player shall mean a player who has been released by a Zone to play on a team within another Zone, when the player's primary place of residence lies within the releasing Zone's residential boundaries.
- 1.19 Responsible Adult is an individual who is at least 18 years of age who acts in the capacity of Coach or Manager for a specific game or series of games.
- 1.20 Season of Play As outlined in EYBA Annual Calendar
- 1.21 Suspension A disciplinary measure that may result from a violation of EYBA League rules, covered in "Section 11 Discipline". Suspended Players/Coaches/Members may not attend the EYBA Sanctioned game/s and Events they are suspended from.
- 1.22 Unsportsmanlike Foul Classified as a technical foul for ejection purposes.
- 1.23 Zones shall mean an association that is duly recognized as a participant in the EYBA and has met the criteria set forth in the EYBA By-laws for participation.
