Board Reports

2020 AGM - ACTING PRESIDENT'S REPORT

The slo-pitch season of 2020 was not without its difficulties. There were times when we thought there wouldn't be a season. The board was meeting every week to figure out what we needed to be done to get things going if and when we could start. We unfortunately lost a few good people on the board and we had many of our members not play due to personal circumstances related to COVID- 19.

On the positive side, we were one of the few leagues to play an almost complete season with 2 cohorts of 50 and to have no members get sick. This was the result of everyone's commitment to each other to keep everyone healthy and safe. Thank you for your hard work!

We as a board have had a steep learning curve this year and as a result, we have put some changes in place to ensure that our league not only functions but grows in the future. We have made suggestions to improve our bylaws, and our accounting practices, we have new ideas to encourage more participation, we have made changes to board positions to divide labour so that our volunteers are not over worked, we have devised some best practices to ensure the security of our facilities and assets as well as board function, and we surveyed our members to get input into improvements for rules and play. We are also working with the Clansmen Rugby Association to approach the City to help with drainage issues and we will be trying to get increases to the money we take in from rentals so that they are more in line with other jurisdictions. Many of these things you have seen in attachments and will be hearing about during the course of this meeting. We, as a board, have been very busy and hope to have your help and continued support in making ESSPA THE place to play ball!

2020 AGM – Maintenance Report – Grant Huys

Covid and constant rain throughout the summer made for a trying year both for ESSPA and Renters of the diamonds. With a very limited budget we were unable to do much except maintain the diamonds for play. We had hoped to add shale, replace the home base mat on Diamond 1 and fill the low areas on Diamond 2 this fall. These will have to wait until next year.

Our Maintenance Costs for the 2020 Season:
Labor costs to maintain the ESSPA Diamonds \$5,500.00
Labor costs to maintain the Rentals Usage \$9,200.00
Expenses for all diamond usage \$1,400.00

Year End Review of

1. Player issues:

Effectively no player discipline issues. A few general squabbles regarding Umpire calls and such that the Team Leaders took control of and limited any real problems. No disciplinary action necessary. This was agreed by all Team Leaders.

2. Exception rules:

- A. Exception rule regarding Courtesy runners was brought up for discussion. After some debate the Exception rule as stated was agreed to be satisfactory by all Team Leaders and will be reviewed in the spring.
- B. 12 foot rule need 12 foot rule to be enforced. 1. Put marker on Back Stop at 12 foot mark for visual reference. 2. Go over all exception rules including 12 foot rule with all designated umpires at the beginning of next season in Hirsch by Team Leaders and Coordinator. Cuthbertson may have their own umpires.

3. Umpires:

- A. Unanimously agreed that designating specific people at the beginning of the year by the Team Leaders to umpire during games resulted in more consistent and competent umpiring. No umpire calls resulted in changing game results.
- B. As noted by Team leaders, the sportsmanship and comradery of the players was on display when they would actually call themselves out if they were out on a play. For example a lead off or a tag the umpire could not see. Etc.
- C. Consideration for all members and those designated to umpire is that the SPN Umpire exam is available on line for free for anyone who wants to take it and it is not as easy as we all may think.

4. Fields:

- A. Great kudos to Grant Huys, Rick Patry and Jamie Parliament from the Team Leaders. Diamonds were meticulously groomed and ready to play every day. Best kept diamonds in the city. A hand.
- B. D1; Fix Diamond Home Plate and mat. Making sure home plate and mat are positioned properly.
- C. D1; Thicker back stop mesh or another layer because still getting glare from cars and buildings behind.
- D. D1; Thoughts to crew about rolling with a big roller to flatten the outfields.

5. Hirsch Division as a Merit Division:

- A. Long general Slopitch discussion regarding everything from full CO-ED division to using 1.21 bats.
- B. General consensus by all Team Leaders is to keep as a Merit Division with all players using the regular ball. To be reviewed depending on circumstances at beginning of next season.
- 6. General thoughts on season: from All Team Leaders
 - 1. Overall great season. Players enjoyed themselves. Many compliments from players from both Divisions.
 - 2. Showed we can play by AHS rules and still have fun.
 - 3. Found that playing with only 4 teams was not an issue and actually brought us closer together as a group because you get to know players on other teams more easily.

7. Other topics

- A. Team Leaders want to stress to players to wear their jerseys. The league is very visible from Kingsway Avenue and the surrounding neighborhood. Jerseys show a commitment to the sport and facility. They show a unified collective support from all members to a <u>cause</u> that almost did not happen.
- B. First Aid Kits need to be refurbished.
- C. Team Leaders would like to work towards having specific jerseys for each team. Whether that means sponsorship or purchase. To be discussed at executive level.

In Summary:

We finally organized to start playing our first game on Tuesday June 30, 2020.

Due to rainouts we finally played our first full game on Tuesday, July 14 believe it or not.

We persevered and by the end each team played 21 regular season games and 3 playoff games each minimum. The 2 finals teams actually had 26 games.

The season was a great success. There was a unique commitment from all players from all skill levels to enjoy the season with an emphasis on enjoyment and friendship. Thanks to all the players for their participation and positive attitude.
