

## Guidelines for Renters at the Fairview Curling and Recreation Club

Thanks for choosing the Fairview Curling and Recreation Club for your event. The information below should help to kick start your bonspiel and make it a fun, enjoyable and safe event. If you have any questions or feedback, please feel free to contact the club, by e-mail fairviewcurling@gmail.com

#### Some basic safety and operational rules:

- Make sure everyone has clean shoes. They cannot have been worn outside.
- Please don't lift the rocks off the ice. This is unsafe and often results in damage to
- the ice. Damage to the ice and hack will be charged by the hour to fix (see 'Ice Repair').
- Throw in pairs, one to deliver the rock, the other to 'catch' it at the far end.
- Return the rocks, slider, and brooms to their original spots at the end of the game.

#### What to Wear:

- Loose fitting clothes that are warm, comfortable, and flexible.
- Sneakers that are clean, have not been worn outside, and have good grip.
- Hats, Gloves / Mittens in case your hands get cold in the ice shed.
- We recommend wearing two grippers at all times, other than when delivering the
- rocks. Sliders to deliver the rocks may be worn if the curler feels safe doing so.
- We recommend wearing protective head gear, especially if the curler is new to
- the game.

## **Equipment:**

We provide all the equipment required for play: brooms, sliders, stabilizers, grippers.

#### Ice Repair:

Damage done to the ice surface can be prevented 99.9% of the time by being safe, knowing the rules, and using common sense. The two most common causes of ice damage are picking up the stones, and hitting a hack with a stone. If this damage occurs during your rental, the labour cost of these repairs will be charged to your account. The cost for these repairs is \$100/hour. By not lifting stones, and using common sense, you can avoid this damage.

## **Rental Agreement Document:**

By signing the Rental Agreement, you acknowledge that you have read, and agree to play by the guidelines detailed in this document, and will communicate these requirements to all members of your group.

## **Health and Safety Waiver**

**Each curler will be required to sign a Health and Safety waiver**, prior to playing. If they are under 18 they will need a parent or guardian to sign. The waiver can be filled out online or in person at the Club. There will be a QR code and paper versions available.
