1. I, the undersigned, certify the information on the registration form to be true and consent to the player(named below) participating in the Falcons U-18 4 on 4 Draft Tournament of the Fairview Minor Hockey Association-(hereafter referred to as FMHA). I further agree to abide by and be subject to the constitution, bylaws, regulations, rules, and decisions of the FMHA, Hockey Alberta and Hockey Canada. I am aware that copies of the rules and regulations are available from the FMHA upon request.
2. I, the undersigned, understand that hockey is a vigorous and physically demanding game in which injuries may occur. I hereby agree to accept the reasonable risk inherent in the game of hockey including the risk of serious personal injury. The undersigned, for himself, herself,themselves, their next of kin, executors, administrators assigns, hereby irrevocably releases the FMHA, its officers, directors, coaches, assistant coaches, trainers, managers,referees, officials, servants agents and employees from all manner of claims or causes by actions in any way related to personal injury or property damage sustained by the registered player and or the undersigned in the course of participating in, viewing, or travelling to or from any of the games sanctioned in this tournament.
3. **I, the undersigned, agree to abide by the following conditions of registration for this 4 on 4 tournament as set out by the FMHA:**
 - a. Players will, at all times, on and off the ice, conduct themselves in a sportsmanlike manner, according to the FMHA Code of Conduct. Infractions of the rules may result in the imposition of severe penalties, including suspension from further play.
 - b. All Jerseys issued by FMHA are property of FMHA and are to be returned following the last game of the tournament that the player is playing. Jerseys not returned following the tournament will be subject to a replacement fee that will be provided by the tournament director.
 - c. All players attending this 4 on 4 Tournament must wear a CSA approved type helmet, which fastens under the chin, together with a CSA approved facemask. They must wear protective devices such as athletic supports with cups, shin guards, hockey gloves, neck/throat protectors, shoulder pads, elbow pads, kidney protectors, hockey pants, etc. In addition, goaltenders must wear an approved type of facemask, as well as an approved head and throat protector. Insurance is void if a player's helmet is removed while he/she is on the ice or on the bench.
 - d. The responsibility for the transportation of players to and from games rests with the parents or guardians, under direction of the team coach.
