

## tteBINGO FAQ

### **Why are we doing Bingos?**

- We are always looking at ways to bring in fundraising dollars to assist with keeping fees down, equipment needs etc.
- It's a consistent stream of income
- The intent is that it will be the only source of fundraising and hopefully no requirement to do the raffle etc.

### **What happens if I can't make my scheduled bingo?**

- If you commit your name/or someone you know to work in your place and you or they cannot attend – it is YOUR RESPONSIBILITY to find a replacement worker and notify [fundraising@fortsaskringette.com](mailto:fundraising@fortsaskringette.com) ASAP.
- ***If you or someone you know does not attend you will be charged a penalty of \$75 that will be payable to FSRA – Ringette within 30 days of missed Bingo. IF payment is not made, the member will be held in bad standing. Volunteering for additional Bingo's does not exempt the member from the monetary penalty.***
- ***If you do not sign up for the allocated Bingo shifts for the 2020/2001 Season the member will be in Bad Standing for the 2021/2022 Season and/or have their participation cheque cashed***
- For the Bingo to run successfully and for us to make the most profit we can we need ALL positions filled.
- FSRA can be fined if we do not have enough workers to fill the positions.

## FSRA & Bingo Hall Rules/Requirements

1. **Please arrive on time.** If you will be late, please contact the fundraising director ASAP
2. Please respect all employees and players in the bingo hall (the employees are there to help us make as much money for the club as possible. Please respect their decisions and follow what they say.)
3. **When on the floor, please refrain from standing in one spot and talking too much. It is important to call back bingos as fast as possible. The faster we call them back the faster we get home.**
4. No sitting, reading or use of cell phone while working on the floor (if you do use it on break or go to the volunteer break room)
5. **Absolutely no going outside or to the bathroom or eating with your apron on.** You must return it to the counter where you got it from before leaving.
6. **Only take your breaks at the appropriate times,** if you need to take extra breaks please limit them to as short as possible and do so in the volunteer room. Do not have too many on a break at the same time.
7. Breaks NEVER happen when the players have breaks as it's good time to sell
8. Volunteer must be over the age of **18**
9. *No alcohol or drugs consumed during bingo shift*
10. Must show up ready to go and not under the influence of alcohol or drugs
11. Water bottles are allowed and encouraged to bring
12. Minimal Training will be given prior to shift start
13. Nut and Scent Free Building

## **1.0** Terms

**Good Standing** – “Member in Good Standing” is defined as an individual or family member that has no disciplinary grievances either lodged or pending against them, no history of disciplinary measures and no outstanding fees owed to any of the sports under FSMSA.

#### **4.0 Policy**

- 4.1 *All members must participate in the functioning of the FSRA by openly and actively participating, organizing, coordinating, directing, managing, or coaching within the program. Members must volunteer and fulfill a minimum number of hours or pay the participation fee as set by the Executive Board.*
