2. Scheduler's report

- Teams may get an extra game in the A division to account for the team folding as we are already committed to the ice.
- 10pm Sat night solo slot is a difficult time to find refs so be really kind to those refs and there maybe times you only have one ref. Team will work on finding different ice time.
- Request for teams not to play at certain arenas, can't accommodate
 those request. Brewer is big one. Did mention to the City, but we still
 get ice at that arena as the City deems it safe for adults. An effort has
 been made to spread out the timeslots amongst all the team so not as
 dramatic affect on teams. Question, can we not keep 10pm Ray Friel
 instead of 10pm Ray Friel, good question, there is the east to west
 issue and late hour when people work the next day. But it is a good
 point.
- Fall schedule will be on in one week. Winter schedule in early Dec.
 After the Nov AGM.
- B division has become big, so it is split into two. A division is staying as one since lots of movements.

3. Adult Development Coordinator

- Chanelle Toshev presented with Eastern Region Volunteer of the Year award for her dedication and hard work on keeping the Silverspoon tournament and her efforts for furthering adult ringette.

4. Registrar's report -

- please save GAARA template with team name, if you make changes resave it and add the date so Maureen knows which is the most recent version.
- Payment goes to treasurer not registrar.
- If you need to make changes, add date to it.
- All TRF will be out in Oct. Email will be sent to all teams to get TRFs signed and returned to Maureen.
- Ellorie Hanson and Maureen discussed the Nov 1 cut off date for any changes to the TRFs as a hard deadline this year.
- Ellorie receives more request for changes from GAARA than entire region. Partially because rosters are too small. Need to look at rosters now and carry extra players. NO blanket signing off on requests this year. Need to justify the change. Adjustment forms are exceptions, not a process. They could be declined as need to get our ducks in a row. This is the reason why GAARA asked for 13 players on the template as most players were only carrying 10 players.

5. Coaching coordinator's report -

 GAARA website has an updated coaching section. Everything is summarized on the site. If you have any questions send Karyn

- question and she will add to FAQ as you are probably not the only one.
- ORA decided head coaches 18+ BB and below can now have CSI or CI. A need CI.
- Clinics will be in Oct and Nov.
- Question about acquiring PD points. After taking a coaching course you have 5 years to acquire a set amount of PD points to keep your coaching status. For CSI coach you need 10 points and 20 points for CI. Get points by coaching and taking courses, rule changes, first aid. Courses taken for other sports may count, contact Caryn to see if they qualify. If you are coaching you have to self report and add them to the profile. Do not get multiple points for coaching more than one team per year. Trainers and managers positions on a TRF do not qualify for PD points. If you don't get the points, and you expired, you do not have to redo the course, you need to acquire the points. You can check your status on your coaching profile on coach.ca
- BB and lower teams don't have to have a head coach for the league, they are required to have a designated individual and that individual will get the suspension or discipline if happens. ORA may be looking at having switch back to having a head coach.

6. Webmaster's report – by email

- Password for spare page, complaints last year that this was not private enough, so password has been added. Password is going to be gaaraspares All one word, no caps, no spaces
- New recruits should be emailing webmaster to have their info removed from the list.

7. Silverspoon report -

10.ERRA rep for G & T -

- Teams attending tournaments in Quebec (or another province) must fill out of province form 30 days before you go or you won't have insurance coverage.
- Police checks might be coming back for adults. Teams may have to pay for this cost.
- New rule, can only have four substitutes at a tournament and only two can be lateral substitutes and they include goalies.
- TRF Substitution forms; A and above go to Steve, BB and below goes to Dave
- 48hrs before you go to tournament need the adjustments approved. If it is after the 48hrs may not get approved as has to be approved by all the G & T reps in province. Point of focus for this season so get it done early.
- If there is a major penalty (4min) that can not be fully severed in the game the player receives a one game suspension. All 4 minutes penalties need to be reported by both teams to G & T.
- If you are scheduled to spare with another team, you can't do it, you have to serve the suspension with your home team. Currently not suspended from coaching. If you are a referring, you can ref. This does not apply to other types of suspensions, ie match penalty, suspended from everything. This will be voted on this weekend. Steve will update thru email.
