Disciplinary Statement

In an effort to ensure that everyone has a fantastic hockey season, The Gleichen Pond Hockey Association has developed a statement around discipline and the coach's authority on the ice. Efforts will be made to resolve issues at the lowest level (verbal warning) however there may be instances where further action is required (refusal to adhere to verbal warnings, repeated inappropriate behaviour/actions, deliberate/intentional harm of another player). In these situations, our association has adopted a 3 Strike Rule:

- ✓ Strike 1: Player will be benched for a period of time deemed appropriate by the coach;
- ✓ Strike 2: Player is removed from the ice and a meeting with the parents, coach and a Board Representative will occur to discuss/resolve the issue;
- ✓ Strike 3: Player will be dismissed from the program pending a meeting with parents, coach and a Board Representative.
