The play then quickly broke out of the corner when #20 (Jones-Yellow), hooked #5 (English-White) under the arm pit and pulled him to the ground. #5 (English-White), immediately got up and started to push #20 (Jones-Yellow) and said "come on lets go for it, you are a chicken shit", he got no reaction, he then pushed #20 (Jones-Yellow) and took a swing at him. #20 (Jones-Yellow) then retaliated and both dropped their gloves and got into a clinch and made 4-5 swings at each other connecting in the upper body and side of the head/face. Both officials immediately broke up the fight with not other incidents and only a few colourful words directed by both players at each other. Both players were escorted off the floor to their respective dressing rooms without further incident. Referee Lamont French made the call and at the time I was standing about 10 feet away and had a clear and unobstructed view of the incident.
