- 4) Presidents Report Phil Singeris
 - First full season since Covid
 - Losing U12A for next season as U12 is now considered regional program only.
 - Expecting 58 teams next season which is increased from 54 from last season.
 - GLRL appreciates all the efforts of executive, reps and volunteers to make GLRL happen.
 - Acknowledged and congratulated the league champions and the GLRL league games that helps develop these teams to be able to play in greater play such as Eastern and Western Championships

5) Treasurer's Report - Tom Anderson

- Revenue based on \$100 fee each team paid for this season.
- Bonds held in trust in savings account which is generating interest payments as well.
- Ringette Ontario appears to still be paying for the RAMP Website, but this could be a future expense.
- Newmarket bond fee was returned as they are no longer a member.
- Surplus for this year is \$5100.
- Bank Account shows approx. \$11,000.
- Growth of \$4800 this year
- Requested if membership has any ideas on how to address the overage. Examples, reduce team fees, or other suggestions on spend.
 - Shelley suggested that GLRL may need to take on provincial ref costs if regions no longer exist as per RO changes coming in Fall 2023. Western Region is covering ref, but Southern region is not, and associations are expected to cover the cost. Central region does have a central scheduler for refs.

- Andrea Law would like to see some funding going to development of refs.
- Question: where does the funding for the Gord Bell award go? CORL provided 4 years of \$500 awards but now the award has been built into operating costs.
- Some do not think \$11,000 is too much money in the bank as there could be a buffer needed if tough times and/or additional costs such as hiring a scheduler for league or refs is required.

Action Item: President to send email to regions to confirm who the rep will be for upcoming season 2023-2024

- 9) Presentation & Adoption of GLRL Safety/Supplementary Discipline Committee
 - Policy has been circulated to reps prior to the AGM meeting.
 - Key Summary Points:
 - Meant to provide accountability for dangerous behaviour that was not addressed by officials in a game. Meant to make the game safer.
 - o An outlet for frustrated players and parents
 - \circ $\;$ Would allow for a video 45 seconds or less.
 - Was vetted through officials and some officials concerned that GLRL could overstep.
 - o 3-person committee to review the incidents and suggest decision to GLRL
 - This is meant to be the last resort, must be submitted through GLRL and has a \$150 submission fee from the association.
 - Calls for committee up to 5 members with a minimum of 3 members would be in place before first league game.

- Only applies to league games in GLRL.
- Submission should be submitted within 7 days of the game. Discussion around aligning with 14 days as per RO policy but was determined to be kept at 7 days.
- Concerns:
 - RO ignores videos so complaints come to regional chairs, suggests that a ref is included in the 3-person committee.
 - Suggestions that there needs to be a clear path of escalation.
 - Concern that committee may be interpreting rules of play and infractions and may not be trained as refs to make the calls.
 - o If paying \$150 should be allowed to submit multiple videos for review
 - Concern that this could target teams and players.
- Changes to policy:
 - Change to minimum of 3 members up to 5 members. Voting to pass must be 51%
 - If the committee member has a conflict of interest, the Executive Chair can assign another member temporarily appointed on case-by-case basis.
 - Raise submission fee to \$300 as paid and provided by the association. The association is responsible to collect fees from team, coach and/or parent/player.
 - Add clarification that review would be during the time the teams have stepped on the ice and stepped off the ice.
 - Need to add submission details that are required when submitting including: date of game, time of game, opponent, location, context and jersey #.
 - Update point 11 the offense count will continue to double year over year, but fines will reset the beginning of each league year. Add "multiple **athlete** offenders".
 - Update point 11a change fines to double at third offense \$200 then \$400 for 4th offense.
 - Update point 10 update "repeat athlete offenders."
 - Update point 9b add issue letter and/or administrative educational responsibility.
 - Remove "educational sessions" from the language within the policy because there are no parameters around what this means and who will provide this.

Action Item: GLRL needs to send notification to all associations before the start of next season regarding the introduction of this new policy with the expectations that each association will communicate to all coaches. GLRL can also notify coaches but only after the association has been notified and has time to disseminate the information.

Action Item: GLRL to review Ref in Chief listed on GLRL website as people have emailed with no response – Steve Baker

- Motion to Approve Vote to add the supplementary discipline committee policy to the GLRL official rules.
 - Nominated by Jim File
 - Seconded by Brian Kettle
 - All in favour Carried unanimously.
- 10) Sudbury U16AA Team playing in GLRL for 2023/24 Season
 - GLRL contacted by Sudbury U16AA manager to request to play in GLRL next season.
 - No teams will be required to travel to Sudbury.
 - Propose to bring Sudbury into the league as a 16-game season.
 - League games would be split out on 4 weekends 4 games per weekend.

- September 23/24th weekend play Kitchener 2 games and London 2 games. Waterloo games will be considered Sudbury's home games.
- \circ Oct 14th/15th play Richmond Hill and Oshawa in Port Carling 1 game per association.
- January play Burlington and Mississauga
- February play Richmond Hill and Oshawa
- Reason this is brought to GLRL, you have to be a member of one of the 3 regions: Southern, Central or Western and Sudbury is not a member so a vote must take place.
- Barrie stated they have been working with Sudbury for the past 3 years and the Sudbury team if very committed to travel and making this work. Sudbury looking for a true experience as AA.
- Question: if we vote for Sudbury to join the GLRL, is this a one-year trial or will Sudbury be a member going forward? The motion will be for 1 year trial of Sudbury to join GLRL.

Action: Confirm the bylaw states how the banners are awarded at end of year - based on points

Scheduling Request:

- August 1st all ice must be submitted to GLRL.
- GLRL to send form for associations to submit.
- AA ice is first to tackle and target is to have it done by August 10th
- AA games start the 3rd week of September September 16-17th
- A games start the 4th week of September September 23-24th
- RO is running AAA this year and will assign to tournaments
- 20 game schedule 10 home and 10 away games request 15 time slots per team
- AA will try to get 10-12 games in before Christmas because the finals is in February not March
- AA provincials is March 1-3rd, A provincials is March 15-17th
- Not all teams go to provincials so only top 8-10 teams will go in the province
