

#### 4) Financial Report -Ron McArthur

#### Cash Status

Includes \$8000 from CORL donated to support the Gord Bell Scholarship when the region folded



#### Official Millage Reimbursement Status, proposal for additional fee and current stats

- Purpose of centralizing the ref scheduling was to reduce # of cancellations, better quality of refs for the game and better coordination
- Estimated cost in May was \$24,650 requiring every team to put forward \$425 as team fees for ref (plus \$130/team GLRL costs)
- 50% fewer games have been cancelled
- Estimated ice time savings is estimated between \$5000-\$6000
- Savings in administration for re-scheduling of games
- Cost year to date is \$20,850 hours and the biggest driver of cost is high level refs travel costs
- In general, it's very difficult to cover U19AA games and a lot of work is being done to develop refs this year to close the gap
- In addition, GLRL streamlined the travel costs across regions which has created efficiencies and consistency
- New Expected cost for refs is \$33,000 which is a shortage of \$8,000 so GLRL will be requesting \$160/team in addition to cover the shortage
  - Motion to request each GLRL team to provide \$160 per team in GLRL by February 7<sup>th</sup>,
     2025 to cover the shortage for the 2024-2025 season costs
    - Motion first Jim File
    - Seconded by London
    - No one opposed
    - Invoices are being requested
- Request from Guelph to have GLRL review tiering the cost of refs for future. Associations with AA should be paying more if higher quality refs need to travel further.
  - When GLRL set up the system, it was set up for sharing cost as some associations have their own refs at home.
  - General reason for sharing cost was benefit of the sport and league across the board.
- Senior refs are aging and locating away from city centres requiring more travel. Original idea to
  have refs scheduled for a loop of games, but this is not working out as originally thought due to
  scheduling. GLRL does try to look at this in planning to reduce cost when possible.
- Will look at HUB weekends for U16AA/U19AA in the next year especially with AAA year. Will be considered for 2025-2026. add to AGM Agenda on who can get ice time for weekends.
  - Burlington scheduled U14AA and U16AA games in middle of their tournament which

had refs already there and required no travel.

- Potential hosts Oshawa/Whiby, Guelph from meeting Chat
- How do we develop higher level refs especially in Southern Region
- Action Item Associations to email Chris Sharpe, Ron McArthur, Jim File and Emma Bragg-Smith if there are additional ideas they have about getting qualified refs used more efficiently.

#### Concussion HeadFirst

- Ontario based company associated with University of Waterloo
- Chemical markers in the body can be detected in saliva if a concussion was sustained and testing can be done
- This company is trying to establish test samples for their study
- Looking to gather data in 2025-2026 at no cost to players
- Ron would like to stay in contact HeadFirst and provide updates to GLRL on how they progress
- Need to keep up to date with HeadFirst and involve Ringette Ontario
- Andrew suggestion add consent permission in the RO registration so people can be included in the study
- Motion requested: Ask Ron to keep in touch with HeadFirst and keep GLRL up to date and GLRL to reach out to Ringette Ontario.

## 6) Scheduling Update – Jim File

- A lot less Game Change regusest this year
- Most Game changes are due to scheduling admin items and far less re-schedules being requested for team availability.

#### 7) Officials Update – Rob Ellis for Emma

- Continue to work to get correct level officials to games without cancelling
- Key focus on developing referees
- Question from Burlington are tournaments an opportunity to complete ref evaluations? Rob just completed a bunch of evaluations at Burlington and Waterloo evaluations this past weekend. Every tournament has development planning included.

## 8) RO Board status concerning:

- Concerns with Status of RO board. President resigned plus other
  - Concerns around stability of the sport

- I would like to propose RO consider temporarily inviting sanctioned leagues to the board
- Comments made:
  - It's really important for us to do anything to keep RO stable
  - General agreement around giving support to RO
  - Some encouragement to not just be temporary and include leagues permanently
  - Seems to be a major communication problem between the Board and paid staff
  - Seems to also have instability in retaining paid staff for RO
  - RO committees also are collapsing because they don't have enough members to exist

#### Other Business:

- Tests were done in Kitchener, Mississauga and Ajax to add a flood between period 2 and 3 for U16AA and U19AA. Mixed feedback received across the group. No significant positive feedback was provided so no changes for next season to add a flood.
  - General Feedback:
  - o Fresh ice helped with the flow of the game
  - o Ajax didn't like it at all, and it affected game momentum
  - Refs thought this was great
  - Tournaments would also not be doing the flood so inconsistent between tournaments and league games
  - o Some issues with getting Zamboni scheduled to get on the ice
  - Overall testing didn't require more than 1.5 hours
  - o Does affect referee payment which would increase and put other games at risk
  - Brian recommendation is that this could be done by associations but should not be made mandatory and would need full collaboration between associations and refs
  - GLRL will not move forward with this next season.

## **Brian Kettle report:**

General Feedback was positive, but some definitely did not like it, particularly Ajax. Ajax felt it interrupted their momentum.

#### Positive feedback included.

Helped maintain the speed and flow of the game by removing the snow. I heard specifically from the city of Kitchener, they were surprised that we don't regularly flood, they see it as a safety hazard that we don't.

Safer by filling in, removing some ruts (particularly at 19AA)

Having extra coaching time in the room, rest change to maybe have a quick energy snack definitely came down to prospective. Some teams liked it, others saw no value.

My understanding is that the majority if not all games ended within 1hr 30min. but could easily go long if any Zamboni delays, injuries etc.

#### Cons

Logistics.

Coronation with the cities is key to ensure there is no extra delay waiting for the Zamboni in facilities with multi ice pads. Possible referee schedule concerns if refs need extra time at 1 game before heading to another game.

Cost, additional payment for ref's extra time? Additional ice costs for those associations who book 1h30min ice or back-to-back AA games in a 3hr block.

It would not apply in tournaments initially so players we flip between having the flood and not, depending on League game or Tournament.

  - With dissolving Southern and Central, how do boundaries work. RO Bylaws stated that boundaries will only change with approval of the board of directors.
  - Releases are RO forms and will still need people to facilitate the use of them.
  - Request from Scheduler to ensure U19AA/U19A teams are formed in Spring and not in Fall as it would affect the GLRL schedule Request send email to Association Presidents to remind them of the impact and need to have Spring tryouts for 2025-2026
