Updates to the Executive/Board:

New Treasurer voted in on August 26th by executive – Ron McArthur and will be starting at the next meeting.

Director at Large positions used to be region specific, but regions are dissolving so name changed to elected positions.

GLRL Board Observers are not part of the executive but are part of the board as per the Incorporated Bylaws.

4) Planning for 2024/25 Season

- No U12 Teams in GLRL any longer, was removed in 2023
- Blackout Dates Submission of blackout dates was better then last year. Some associations were very heavy for blackout dates in 2nd half.
- Blackout dates are no longer being accepted for this year Email sent by GLRL on August 23rd to all GLRL reps and coaches.
- Any changes to schedules will need to be addressed via the Game Change Form process.

5) Season Scheduling Update - Jim File

- U19AA and U16AA is on GLRL website.
- As of August 26, U14AA schedule also loaded but may require some changes.
- U19A, U16A are imminent to be loaded to website.
- U14A more work to be done.
- Schedule Format U16AA & U19 AA Teams 4 x 11 Min Periods with 1 time out per half.
 - REMINDER NEW 5 MIN WARMUP THIS SEASON! LET MINOR OFFICALS AND REFS KNOW!
- Schedule Format A Teams 2 x 15 Min & U14AA 2 x 15 Min
- 20 Games per division (Sudbury 16 total for U16AA)
- Reminder that some associations: Ajax, Cambridge, RH, Whitby, Etobicoke and Burlington has flood at start of ice time.
 - Team composition and acknowledgement: All teams declared as female only. There was no male only or mixed teams for this season.

Discussion:

- Consider adding a maximum number of blackout dates that allowed to be submitted when lce submission is provided. Suggestion: you are allowed to provide 4 black out dates and any additional needs to have explanation.
- Some associations are blacking out dates to enforce participation in association events. Examples: Santa Claus Parade

7) GLRL Team Fees for 2024/25 Season

Payment Deadline due prior to team's first league game


- RO has introduced a new sanctioning fee for all leagues of \$1000 for this coming season.
- All Bonds will be held in trust. Will need to collect from Hamilton new to GLRL this year prior to 1st game of the season.

Action Item: Hamilton to provide bond cheque for \$500 to be held in trust.

- Does Cambridge have one still in place? Yes, Bond in place.
- Additional expenses since AGM: Incorporation approx. \$2000 and additional awards paid for.
- Expenses came in approximately \$500 lower than expected for last year.
- All Treasurer access and tools being transferred to new Treasurer, Ron McArthur over the next several months.
- Action Item: Tom Anderson will send payment details to all associations via email after the meeting. GLRLtreasurer@gmail.com
- Savings Account reflects the 22 associations with bond fees.

 - Process was tested last season and process worked far better than originally thought. Decision was made unanimously, and process was carried out. Process was also completed in a timely manner.

10) Official's- Emma Bragg Smith

- Emma is new RIC for league.
- Three new Official's Schedulers in place (Steve, Rob and Tara)
- Starting to load schedules into Arbiter.
- Email will go out to all GLRL officials in next day or two to registers for Arbiter. All GLRL game assignments will come from Arbiter.
- Both U14A officials to be scheduled by GLRL
- Officials to be paid millage by GLRL, through Officials Schedulers, approval by Emma and paid out by treasurer, 4 times per season (End of: Oct, Dec, Feb, April)
- Reminder Officials Millage for exhibition & LORO games must be paid by home association, not paid by GLRL.

- Action Item: GLRL reps need to communicate to officials that mileage is being paid 4 times/year.
 If official is ref for multiple games, need to ensure mileage is split between GLRL games and regional games (paid by association) as required.
- Dorchester has concerns about how mileage is split.
- Example: If official completes A game, then travels to B game, then completes another A game. Mileage should be split so that 2/3 paid by GLRL and the 1/3 of mileage paid by local association because not GLRL game.
- Holly Davies (Oshawa) perspective is that the process with spreadsheets is working really well right now for Oshawa and will be seamless.

11) League Sanctioning by RO

- RO has sent us list of items we need to have in place for league to be sanctioned. Executive is working on this and should have formal application in this week.
- We must use Ramp Game Sheets for all league games.
- All BOD/Exec committee must be registered with RO. Cost to be covered by GLRL.
- Provide Copy of league rules (these are updated on web site)
- We need to create:
 - i. Social Media Policy,
 - ii. Screening Policy (We are going to use Stirling Background Check) to be completed by all of board and board observers except Convenors,
 - iii. Discipline & Complaints Policy,

Action Item: GLRL required to apply for league application to be sanctioned under Ringette Ontario.
