Discussion:

- New website using RAMP that is hosted by Ringette Ontario
- Reminders on how to report scores was addressed by Shannon
 - o GLRL reps were sent an email with team username and passwords to login and report scores
 - o Teams must enter home and visitor score
 - Teams must check the "Game is Finished" checkbox in order to have the game count in the statistics

- How to track major penalties?
 - Ramp website not able to track
 - Meeting Jim, Nancy, and Shannon to discuss how to add to game sheets for penalties and define requirements of what we need and how it will be entered.
 - Nancy to send Shannon the google form to post on GLRL website for reporting major penalties
 - Burlington request what is the correct process if the game score was entered incorrectly?
 - Process is to change the score if incorrect coach should contact the team for them to go in and edit
 - Should go to the U12A convenor to report
- Andrea Law reminded everyone to put a note regarding substitutions on the game sheets
- Forest asked if the score should be entered with 7 goals spread or should be actual score?
 - Ringette rules state that only 7 game score should be entered
- Tom Anderson (Treasurer) asked who should be keeping game sheets
 - Game sheets are not being submitted

7) GLRL Representatives Responsibilities

- Communication from GLRL to Home Association
- Communication to GLRL from Home Association
- Lots of communication has come from GLRL lately and some reps are passing information forward and some are not
- It's the responsibility of the GLRL rep to get the information back to the Home Association Presidents and coaches
- The expectation of GLRL rep is to summarize the meeting and provide a report to the Association

8) GLRL Rules

- Know the Rules!
- Rules Review Sub-Committee
- GLRL has had 2 major issues reported this week and there are concerns about coaches and associations not knowing the rules.
- GLRL rules are on the website, coaches need to read the rules and understand the rules.
- Key rules to understand including Ringette Ontario Substitution rules and GLRL substitution rules.
- GLRL rules were created by a merger of rules in 2019 when regions were merged, they will need updating and changes.
- GLRL rules have only had ½ a season of league play to see if there are concerns and evaluate their effectiveness.

9) Other Business

a) U12A team concern raised

- Concern with Dorchester U12A being very strong
- Concern that coach is holding players back because of the score difference and this will affect the development of the girls. Concern raised by another coach not as complaint but as worry about league play.
- Suggestions of moving girls up to U14A or moving to play other centres that may be more competitive. This would need to be a formal request to move to U14 to come to the league. If G&T moves the team up, then they must play U14 in league and in tournaments
- Because Dorchester has other teams, they are competitive with such as Burlington, would not suggest moving up right now
- Need to evaluate Tier 1, 2 and 3 for league play and look at changing circuit
- Western Region rep (Chris Sharpe) stated that having meaningful play is an important aspect to consider. Suggest having U14A exhibition game to evaluate how they would do.
- b) Concerns with game start time and delays
 - There are implications of not starting league games on time. Coaches need to be aware.
 - Make sure coaches and associations read and understand the rules.
 - Rule interpretation can be different but need to understand the content of the rules.
 - Also issues with substitution rules that have been seen. Issues were due to coaches not understanding the rules in place.
- c) Current Issues with a team wanting to use a Male goalie in league play
 - Executive is currently taking this under review
 - Ringette Ontario is requiring declaration of mixed teams
 - This is still under review of the league and a decision has not been made but associations with teams have been made aware.
