

4) Financial Report –Ron McArthur

- All associations are paid in full
- All bond cheques are received in good order
- The first mileage cheques will be coming out soon which will be a the first time and involves learning curve
- Payouts will be done end of October, December and February and March
- Concern raised to keep young officials in the game, they want payment more often or we may have lose refs due to incurring costs
- Concerns with the amount of bank fees that we could be charged since GLRL is a not-for-profit organization – GLRL is lobbying the bank to lower fees but the dual authentication



5) Discipline Committee – Jim File/Brian Kettles

- Reps from Ajax, Western and Richmond Hill will be returning on the committee
- Committee consists of same members as last year
- No concerns submitted for this year

Update on Suspensions in Game sheets

- Action Item: Request to add Association President to the Suspension workflow could only
 add as manual email as association president email not in RAMP tied to team or player. Need
 to meet with RO to see if this can occur.
- Workflow is listed on the GLRL website
- One issue we are seeing is if Match Penalties are entered in error, we can delete the penalty but we are unable to delete the suspension already put into the game sheets. RAMP is aware and working on this.
- Action Item: Request to RO on how Tournament Convenors are being notified for Suspensions
- Concerns raised How to find the Game Code & Official Code
 - Action Item: Shannon to send Official Codes from RAMP to Emma
 - Action Item: One page instructions on website on how to find game code and official code

6) Scheduling Update – Jim File

- Scheduling went better than expected
- Number of Game Change Forms brought in compared to last year decrease by half from 2023
- May look to have AA start 3rd weekend in September and maybe move A to same weekend
- Some concerns around Thanksgiving weekend if you don't want to play on this weekend, then must be blacked out

7) Officials Update - Emma Bragg-Smith

- Arbiter update everyone has been added
- We have had some struggles to make games happen. Official schedulers are doing what they can to get games filled. Will become more difficult as tournaments start up
- It is not the association's responsibility to schedule officials for games. If the games are going to be cancelled due to officials' shortage, the officials schedulers will reach out to you
- Every week is being scheduled right to the last minute
- At this point, only 1 game re-scheduled due to officials but this was done too soon by association, need to contact the RIC to confirm before re-scheduling
 - o Raised that Forest vs Waterloo also cancelled due to lack of refs Emma to follow up on this one
- With Tournaments coming in, it will test the system for scheduling
- Question: is there an opportunity to get more evaluations of referees completed to move refs up levels?
 There are opportunities. Cannot schedule evaluations until all officials have taken the mandatory refresher clinic.

- General Liability insurance is in place.

Other Business:

- Looking at testing a flood between period after period 2 for U16AA and U19AA. Games slow down and ice is pretty rough shape by end of the 4 period games. Possibly safety concerns raised (without specific data) but also may just make the game better with fresh ice. This could impact the ability to get games done without two hours of ice.
 - Concerns around safety of players and officials, ice deteriorating
 - Mississauga will try this as first attempt to gain feedback (suggestion to ensure more than 1 trial)
 - Impacts: Scheduling for ref, cost of refs, availability of arena staff
 - Evaluation will get feedback from coaches, refs from the trial
 - Request will be made to all reps to talk to their associations, coaches, RIC and arena staff to see if this is possible. Would only affect the associations hosting U16AA and U19AA.
- Concerns raised about new goalie warmup rule by specific officials
 - Referee raised concern that rings on the ice for goalie warm-up is contradicting the Ringette Canada rule. Goalie warm-up does not need to have rings shot on the goalie.
 - Action Item: update rules for 30 sec to stretch, no rings on the ice. Email Coaches about new policies and updated rules.
 - Clarification of rule instead of Update not requiring
- A (Sault Ste. Marie March 13-16, 2025) & AA Provincials (Ottawa March 30-April 5, 2025)
 - Intents are open and to be submitted before Nov 15.
 - -Your teams must also book hotels through RO provider or will get fined likely. No specific fine amount confirmed
- CRC Intents to proceed now open with the Provincials Intents
 - Costs have increased to \$3000 entrance fee.
 - Also, now teams must use hotel provider for the event or will be fined.
